



RE: Lucas County 2018 Reappraisal

On June 4, 2018 the Lucas County Auditor filed a tentative abstract of the values produced by its 2018 sexennial reappraisal. Pursuant to Ohio Administrative Code section 5703-25-16, the Tax Commissioner reviewed those values and found that residential property han not been assessed at its true value in money. The Commissioner informed the County of the specific areas that were underassessed and made recommendations for the necessary adjustments in each of those areas.

The County responded to the Commissioner's notice by filing a second and then a third correcting tentative abstract, neither of which brought the values into the minimum compliance range according to the Commissioner's sales ratio studies. On June 26, 2018 the County filed a fourth tentative abstract that incorporated the changes requested by the Commissioner. In response, the Commissioner issued Journal Entry Number 18-05-0111 on June 28, 2018 accepting the proposed total market value of \$21,370,286,900 and instructing the Auditor to prepare a final abstract of taxable values that would show 35% of the approved amount (approximately \$7,480 Million) plus the taxable value of minerals and new construction and less the reduction in taxable value for property on the CAUV program.

By email dated October 31, 2018, the County notified the Commissioner that due to input from taxpayers the county had decided to abandon the values approved by the Commissioner in June and instead file a final abstract of values based on its initial tentative abstract filed on June 4, 2018. that final abstract is now properly before the Commissioner for review pursuant to RC 5715.24.

The Commissioner finds that the final abstract is not in compliance with the requirement that real property be valued at its true value in money and as ordered by the Journal Entry 18-05-0111. Therefore, the following changes in residential value are hereby ordered:

## **A More Diverse Congress, a More Perfect Union?**

The 116th Congress, sworn in on January 3, is the most diverse our nation has ever seen. There are more women – 102 – than ever before. More members of the Congressional Black Caucus – 55 – than ever before. Indeed, a former Congressional Black Caucus intern, Lauren Underwood (D-IL) is part of the incoming first-year class. At 32, she is the youngest Black woman to serve.

This Congress includes the first Native American woman, two Muslim women, openly gay representatives, and others. Much of this diversity was displayed at the ceremonial swearing-in of the Congressional Black Caucus, an inspirational event that preceded the official swearing-in on Capitol Hill. There, as I listened to speeches by the top Congressional Democrats – incoming speaker Nancy Pelosi (CA), incoming Majority leader Steny Hoyer (MD), and incoming Whip James Clyburn (SC), I was awash in hope and optimism. These leaders, along with outgoing Congressional Black Caucus Chairman Cedric Richmond (LA) and incoming Chair Karen Bass (CA) spoke of challenge, struggle, and optimism and focused on possibilities.

As I listened to them I could not help but think of the poet Langston Hughes, and his poem Let America Be America Again. Written in 1935, the poem was first published in Esquire Magazine in 1936. Though Hughes did not consider it one of his favorites, it captures the duality of our nation, the marked difference between our nation's soaring establishing rhetoric and the stark reality that many experience. In the words of Malcolm X, it is the difference between the American dream and the American nightmare. Here is what Langston Hughes writes in his poem:

"Let America be America again. Let it be the dream it used to be. Let it be the pioneer on the plain Seeking a home where he himself is free. (America never

was America to me.) Let America be the dream the dreamers dreamed— Let it be that great strong land of love Where never kings connive nor tyrants scheme That any man be crushed by one above. (It never was America to me.) O, let my land be a land where Liberty Is crowned with no false patriotic wreath, But opportunity is real, and life is free, Equality is in the air we breathe."

(There's never been equality for me, Nor freedom in this "homeland of the free.")

No freedom in this homeland of the free, but this Congress offers freedom possibilities. It offers the possibility of fixing the Voting Rights Act, even as the Supreme Court has attempted to erode voting rights, even as at least two elections were stolen in 2018, those of Stacey Abrams in Georgia and Andrew Gillum in Florida.

This Congress offers freedom possibilities in resisting the insanity of a "wall" that the Great Negotiator (and purported author of The Art of the Deal) swore that Mexico was paying for. Not. This Congress offers freedom possibilities in its efforts to preserve the Affordable Health Care Act and to move us to Medicare for all. This colorful Congress (the pictures tell it all) offers a sharp contrast to the dismal (as in grey and navy suits) set of Republicans, overwhelmingly white and male, and overwhelmingly staid.

It's not about MAGA (Make America Great Again), it's about MAF, or Make America Fair. This is what Congressman James Clyburn shared when he spoke at the ceremonial swearing-in. He opened with the words of French historian Alexis Tocqueville, who observed when visiting this country: "the greatness of America lies not in being more enlightened than any other nation, but rather in her ability to repair her faults."

Clyburn went on to list the many ways our nation has attempted to self-correct, from the passage of the Emancipation Proclamation to the Supreme Court Brown v. Board of Education decision declaring "separate but equal" to be "inherently unequal." Clyburn talked about the

Great Society legislation, another of our nation's attempts at self-repair, and he concluded by saying that, "America does not need to be made great again, she is already great Our challenge is to make

not need to be made great again, she is already great. Our challenge is to make that greatness apply fairly and equitably to all of our citizens."

Can this diverse new Congress make our nation fair for many who have never experienced our nation in the way it is supposed to be? In the words of Langston Hughes, "It never was America to me." We've come a long way since he wrote his 1935 poem, but we still have so much to do. After these last two dystopian years under the leadership of President Genital Grabber (let's just call him GG), this new Congress offers us many possibilities. May they manifest!

that he would curtail the radical elements of the Nazi movementspecifically the S.A. or Stormtroopers-and, as a result, the Reichswehr would lend its support to Hitler's political and military ambitions. While there were probably some in the German military who questioned Hitler's approach, there was little opposition. Instead, the Reichswehr, which later became the Wehrmacht, went forward with naked aggression. Additionally, it abetted the Holocaust carried out against Jews, other minorities and political dissidents. It was only in 1943/1944 when the tide of the war had turned with the German defeat at the hands of Soviet troops in the



Recent events with the administration, Trump including the Bob Woodward book-Fear-and the anonymous op-ed in the New York Times from an alleged member of the Trump administration had me thinking about the July 1944 plot by some of the German military to overthrow Adolph Hitler. My reference to Hitler, just before you jump out of your seat, is not a direct comparison. Rather it is to make a different point.


Germany began an active military buildup shortly after Hitler assumed power. He made an agreement with the Reichswehr (the name for the Germany military) battle of Stalingrad, and the later collapse of Mussolini in Italy, that there was a rethinking. It was a rethinking not based on a moral reawakening among these generals but a recognition that Hitler was in the process of taking Germany down rather than leading it to victory.

The lesson here is important in looking at this moment. There appear to be an increasing number of Republicans who are, quietly and sheepishly, beginning to question the

## It's Raining Legal Freebies...

As it my wont, at the beginning of a new year, I like to shower on my dear readers, legal freebies that may be of SOME utility or value as they navigate that minefield known as the legal system.

It can be full of pits, snares and surprises for the novice, so, in my small way, I like to be a legal cornucopia and spread a little new year's cheer to everyone.

Now mind you, the following legal freebies should only be used in conjunction with an attorney who is knowledgeable of your particular concerns or dilemma.

So, just as you would not go to a dentist to install your home security system, make sure that the attorney you employ is a seasoned hand so you can avoid or minimize any hard lumps.

FREEBIE ONE: If you choose (and you shouldn't) to have a baby outside of

marital wedlock and you want to make sure that you are in the baby's future (even if the birth mother wants to "lock you out"), you can place your name on a putative registry so that your rights as a birth parent are profifteen days of the birth of the child. So. before you buy that first box of "Pampers", get on the registry!

FREEBIE TWO: If you are expecting a "fat" tax refund but still need to file a chapter 7 bankruptcy but have urgent expenses, make sure that you keep a detailed list of whatever you spend out of that tax refund, including all receipts. Why? In the event that you file a bankruptcy and the trustee over your case asks about that X grand return, you can present evidence that you did not fritter it away on loose living and buying the latest Jordan's.

But rather you spent it on necessities including back rent, utilities, food, clothing, attorney fees and costs to file the bankruptcy, etc...etc. Do not pay back friends or family members for any "loans" that they gave you. That won't fly with the bankruptcy trustee.

FREEBIE THREE: Danger! Danger! If you sign a consumer contract for goods and services, you normally have a three day rescission period by which you can reject the contract and not be liable to pay any contractual balance. However, this three days of grace does not apply to buying a car. So, be very sure that you want the car and the car checks out as not being a lemon or it will become your "bank" (in other words, you are always putting money into it!).

FREEBIE FOUR: In the unfortunate event that you are a passenger in a car that is stopped by the police, the police can ask each of the occupants of the car to identify themselves and also to step out of car (safety of the officers).

If that happens to you, please refrain from loud mouthing the police or trying to play tough guy and not cooperate. The owner/driver of the vehicle can protest a search of the car but you can't. So, please cooperate so that you can get home safely and not be a victim of police misconduct.

FREEBIE FIVE: Being evicted? If so,

tected. This needs to be done within make sure that the landlord files the proper paperwork in court and be very careful to make note if the landlord or his agents try to do what is called, "selfhelp" by which they put out your belongings on the curb before the court process has finished. If they try that tactic, they can be sued for damages. Take pictures and have witnesses if at all possible about the damages done to your household goods and furniture.

FREEBIE SIX: If you are facing a foreclosure but want to save the house but the creditor says no, you may file for what is called a Chapter 13 Plan by which, if you qualify, you can save the house from foreclosure and also you can catch up on any past due and owing house payments and property taxes. You must act quickly so that your rights are protected since after the foreclosure is done, your rights are extinguished unless you can pay the due amount in full which may include substantial attorney fees and costs.

FREEBIE SEVEN: If someone dies and they made out a will but you can not find it but you do have a copy of it, you can still ask the local probate court to admit the will and there will be a legal proceeding to validate the copy as if it was the original will. If no original can be found and neither can a copy be found, you can still probate the estate assets of the deceased that are not included in a trust document (trust documents are not admitted to probate court).

FREEBIE EIGHT: In the event that you want to deed property to someone but with conditions, you can do so and thus give a person a "life estate" in the property and when they pass on, you can (in the same document) determines who then gets the property or whether it should revert back to you or your heirs.

FREEBIE NINE: To save money as regards probating one's estate, consider having a possible heir, or two,

placed on your checking or savings account so that in the event that you pass away, those remaining funds are now considered to be owned by those name heirs. This is called a "POD" (payable on death account) and can be set up by going to your bank and adding a name, or more, to the paperwork and thus it is a contract and as such will not be considered a probate asset and thus avoids going through probate.

FREEBIE TEN: In the event that you need to file a bankruptcy or a Chapter 13 Plan, the federal law allows you to include into your monthly budget an amount for tithing to your church (Note: there is no New Testament requirement for tithing, only for joyful giving) and which amount can be up to fifteen percent of your annual gross income. Such giving could make a favorable result in you being able to file either a bankruptcy or a Chapter 13 Plan since that amount lessens what is available to pay to creditors!

FREEBIE ELEVEN: In the event that you are sent an unsolicited gift in the mail (in other words you did not ask for it or order it), it is yours to keep and the sender is out of luck. So, if a package comes to you and you keep it and then you get letters demanding payment or its return, throw the letters away and enjoy the freebie.

FREEBIE TWELVE: If you and your spouse have to separate and you both agree upon a dissolution as opposed to a divorce (dissolution requires no grounds to be proven), make sure that each spouse will be present at the final hearing because if not, and one spouse does not appear, the court will/can dismiss it and you will have to start over and file a more costly divorce action.

Well, there you have it. Freebies for all! Use them wisely and when you are in a contentious situation, do not get angry...get smart. Angry people lose while smart people win.

## Michelle Obama's "Becoming" Will Soon be a Classroom Curriculum For Young Black Girls

Nationwide - Former First Lady Michelle Obama's book Becoming, which sold over 1.4 million copies in its first week of release, has inspired many Black women all over the world. Having been inspired by the book herself, Lauren Christine Mims, a former assistant director of the White House Initiative on Educational Excellence for African Americans, chose Becoming to be a curriculum for Black girls to enhance their learning and development.

Lauren Christine Mims, who will soon earn her Ph.D. of Educational Psychology from the University of Virginia, is just one of the many who have been captivated by Obama's best-selling memoir.

Becom-"Reading ing was like sitting on the couch with your best friend and having one of those soulful conversations about life," Mims told Black Enterprise. "Reading about how Michelle Obama felt unchallenged in elementary school, teased for the way

she spoke, and noticed a difference in how she was perceived during adolescence was affirming."

Upon reading it, Mims realized the impact the book could be able to give on black girls who were striving to find their place in the challenging world. Along with her doctoral research about young, black girls in school, she decided to turn Becoming into a curriculum to further black girls' learning and development.

"I disrupt the traditional practice of talking about black girls in pejorative ways and center them and their unique experiences to study how we can support them. For example. my research highlights what 'Black Girl Magic' means to black girls; the role teachers play in supporting or stopping the success of black girls; and more about what they are learning and how it makes them feel." she said.

The curriculum would include reading Becoming, watching films with black girls as the lead role, and participating in "important conversations, like about what it means to feel like your

presence is a threat or that you do not belong. We will discuss Maddie Whitsett and McKenzie Nicole Adams; two 9-year old black girls who died by suicide after being subjected to bullying. At the end of the course, students will apply their knowledge to draft new research proposals, policies, and practices," Mims said.

Additionally, Mims stated four ways on how we can all support the develtheir needs and centering their unique experiences of Becoming;

\* Advocate for, adopt, and enforce school policies and accountability practices that recognize the brilliance of black girls and ensure they are not being pushed out of school.

\* Address the bullying,

healthcare;

Care for your own mental health and well-being.

Moreover, Mims believes and she wants young black girls to believe that they are enough and they can flourish in a world despite its attempts to deny their humanity.

As told by Michelle

Obama herself, "Becoming isn't about arriving somewhere or achieving a certain aim," yet there is so much pressure in colleae to define your identity and pick a career path. It can take a toll on you. Know that you are brilliant and never "underestimate the importance you can have because history has shown us that courage can be contagious and hope can take on a life of its own."


## **United for Libraries to partner on 'Summer Scares' reading program**




at public and school libraries all over the country, for free.

## Cyntoia Brown granted clemency and said she serves a God of second chances

At long last, one of the greatest injustices in recent history has been corrected.

The Associated Press reports that Tennessee Gov. Bill Haslam granted clemency on Monday to a woman serving a life sentence for murder who says she was a victim of sex trafficking.

The outgoing Republican governor, whose term ends in just two weeks, chose to show mercy to the now 30-year-old Cyntoia Brown by releasing her Aug. 7.

Brown was sentenced to life in prison for killing a man when she was 16. She will remain on pa-

role supervision for 10 years on the condition

she does not violate any state or federal laws, as well as holds a job and participates in regular counseling sessions, the AP reported.

"Cyntoia Brown committed, by her own admission, a horrific crime at the age of 16. Yet, imposing a life sentence on a juvenile that would require her to serve at least 51 years before even being eligible for parole consideration is too harsh, especially in light of the extraordinary steps Ms. Brown has taken to rebuild her life," Haslam said in his statement. Brown's case has attracted national attention from criminal justice reform advocates, and attention has amped up as Haslam's second and final term entered its final weeks. Celebrities like Kim Kardashian West and singer Rihanna threw their support behind the fight for her release. The governor's office was inundated with thousands of phone calls and emails from supporters. "Thank you Governor Haslam," West tweeted soon after news of the

clemency decision broke. Brown was convicted in 2006 of murdering 43-year-old Nashville real estate agent Johnny Allen two years before.

Police said she shot Allen in the back of the head at close range with a loaded gun she brought to rob him after he picked her up at a drive-in in Nashville.

However, according to her lawyers, Brown was a victim of sex trafficking who not only feared for her life but also lacked the mental state to be culpable in the slaying because she was impaired by her mother's alcohol use while she was in the womb.

## When Toddlers Will Eat Dirt, But Not Vegetables

It's common for toddlers to switch up their eating habits, so don't be shocked if they refuse a particular food one day and accept it the next.

If you're trying to get your toddler to accept particular foods, form good eating habits and avoid carrying picky eating into adolescence, consider the tips below:


Serve meals regularly and limit grazing or excessive snacking throughout the day. Meals should be served at the table with other family members, promoting routine and predictability.

Don't let toddlers drink their calories. The American Academy of Pediatrics (AAP) recommends approximately 2.5 servings of dairy per day if your toddler can drink milk, and also discourages juice and soda consumption due to their lack of nutritional value and relationship with childhood obesity.

Offer new foods alongside familiar food your toddler favors. Promoting food diversity and introducing new foods can open up a range of options for your picky eater.

Let toddlers explore their foods, even if they make a mess. Encourage playing, touching, smelling, licking and even taking small bites.

Don't bribe your child to eat healthy food using unhealthy food. The goal is to get your child to enjoy and crave healthy foods instead of simply tolerating them.



Set a good example by eating a nutritious, diverse diet. You are your toddler's most important influence.

Don't stock junk food in your home. If this isn't an option, make sure this food is hard to access for your toddler. Discuss benefits of healthy, nutritious eating. Talk about making healthy choices and eating fresh food instead of processed snacks.

Use toddler-sized portions. A serving size for a toddler is about ¼ of a single adult portion. It's normal for your toddler to take a few bites and feel full. Set a timer for five minutes and slowly extend meal time up to 15 minutes

Minimize distractions at the table

while eating. There are many negative effects that can come from eating while watching television.

Despite negative initial reactions, your child will likely learn to accept the food with time and repeated exposure. Getting a toddler to eat a balanced diet is a long process requiring patience and perseverance. When your children mature into healthy adults, they will learn to appreciate your efforts.


Sometimes it's confusing to know who to contact and for what. Social Security and Medicare offer related services, so people aren't always certain who does what. This "cheat sheet" can help.

Contact Social Security to:

See if you're eligible for Medicare;

Create a my Social Security account to do things like request a replacement







Medicare card and report a change of address, name, or phone number;

Sign up for Medicare Part A (Hospital Insurance) and Medicare Part B (Medical Insurance);

Apply for Extra Help with Medicare prescription drug coverage (Part D) costs;

Report a death; and

Appeal an Income-Related Monthly Adjustment Amount (IRMAA) decision (for people who pay a higher Part B and/ or Part D premium if their income is over a certain amount).


And now Isan is hoping this will be a great excuse for her to go to the annual festival.

time period than normal, the four programs covered two core principals with the lighting of two Kwanzaa candles each day. Ending with the last principal and last candle on the final day.

Day one's opening ceremony was hosted by Master of Ceremony Rodney Gordon Jr. of the Toledo Kwanzaa House Committee, and featured inspirational speakers, traditional African dance performances, audience participation events, community vendors, and food samples.

One of the highlights of the was guest speaker Mrs. Joyce Stubblefield, who educated and amused everyone as she explained the history of collard greens, an African American food staple. 'Slaves were not given meats very often so they ate vegetables instead', she said, 'and they invented different and creative ways to prepare these items'. She introduced the audience to such ideas as the collard greens sandwich, Egg rolls and even brownies, along with many other ways to prepare this favorite vegetable. She

also brought along samples of her collard greens specialties for everyone to taste.

Another outstanding speaker was from The Toledo Kwanzaa House Committee and went by the self-proclaimed name of 'Kewate', he spoke on the second principal of Kwanzaa urging the audience to, 'figure out who you are and be able to discern what is true and what is not true. You are not who society says you are and everything you see, hear or read is not true. If you want to know the truth read the Bible', he said 'there you will find the real truth and discover who you are'.

The program also included the singing of the Black National Anthem, a Recognition of the Elders, an Ancestral Roll Call, as well as several other traditional Kwanzaa customs.

Today's local Kwanzaa celebration evolved from a small and humble beginning back in 1967 in the house of Diane Gordon: Coordinator of the Kwanzaa House Committee. 'I started celebrating Kwanzaa with my family first,' she said, 'and then others soon joined in with us and

it has grown from there to what it is today. Eventually the celebration got too big for my house so we moved it to the Grace Community Center'.

This move however would not be the last. Over and over again as the crowds continued to swell the committee was forces to find larger and larger spaces for the growing audience. Finally, the group ended up at The Douglass Center in the heart of the African American community. A place that has enough room to accommodate the ever-growing audience and all the other activities associated with a true Kwanzaa celebration.

When asked, why is Kwanzaa important and what is the attraction, Diane Gordon said, ' Kwanzaa teaches us about our true culture and the importance of our culture. We are a family orientated people of faith and we need to learn our true history. If you know your history you won't make the same mistake in life. It also instills in us the importance of self-respect and respect for our others. If you understand the principals of Kwanzaa you can

utilize them every day and throughout the rest of our life. Kwanzaa inspires us to unite and come together as a people and build a better community. If we adhere to the principals of Kwanzaa, we will have a better way of life because these principals teach us how we should live'.

Kwanzaa was originally conceived during the African American re-identification period of the racially turbulent sixties in 1966. This unique African Americans festival of life and spirit realized it's 52 year of existence in 2018, and has established its place in the world as a legitimate cultural tradition.

Janece Wooley, the Interim Executive Director of the Fredrick Douglass Community Associations said of the events, 'we are

excited to embark on 100 years of service to this community, and we want to continue to be the epicenter for hope and encouragement. We are very happy and proud that The Toledo Kwanzaa House has chosen us to be bless with this wonderful Kwanzaa celebration for the past three years.

## **Five African American NFL Head Coaches Fired**

Five of the NFL's seven African American head coaches were fired on December 31st. Arizona Cardinals head coach Steve Wilks was fired after just one season. The Cardinals' record was 3-13 — the worst record in the league — but over the last 18 years, there have only been ten head coaches who were fired after only one year. Three of them were African American.

This NFL season the following Black head coaches were fired: Marvin Lewis (Bengals, 6-19), Vance Joseph (Broncos, 6-10), Todd Bowles (Jets, 4-12), Hue Jackson (Browns, 7-8) and Steve Wilks (Cardinals, 3-13).

The firings mean there are now only two Black head coaches in the NFL: Chargers head coach Anthony Lynn and Steelers longtime head coach Mike Tomlin.

The firing of Wilks in Arizona after only one season won particular attention. In the NFL, many coaches fail in their first year yet remain employed. Though the NFL has made great improvements in hiring Black head coaches over the last twenty years as the result the Rooney Rule, the recent firings were sobering. The Rooney Rule mandates that NFL teams interview at last one minority candidate before making their final hiring decision.

Professional football is dominated by African American players, as over 70 percent of them are African American. Typically, players go on to become coaches but the overwhelming numbers on the field have yet to surface among the coaching ranks in the NFL. Many see the recent firings as ironic progress: There was a time when the firing of five African American coaches would have been inconceivable because there were none on the sidelines. However, thirty percent of NFL coaches were Black before the firings this season. Though one of the fired, Hue coaches Jackson, has one of the worst win/loss records in the modern NFL, many point to the fact that there haven't

been enough hired over a long enough time to conclude that the hiring and firing pattern is biased one way or the other. Still others say that management above the head coaching position is actually often to blame for failing results and losing records.

2007-2008, From Lane Kiffin went 5-15 with the Oakland Raiders. From 2000-2002, Dave Campo went 15-33 over two seasons. From 2006-2008, Rod Marinelli went 10-38, which included a 0-16 season, with the Detroit Lions.

"Despite owning one of the league's worst rosters, the Cardinals fired their coach anyway, as Bidwill scapegoated Wilks - who became only the 10th coach to be fired after only one season since 2000 for the franchise's failures," wrote NFL writer for Yahoo News, Terez Paylor, regarding Wilks' firing.

Writer Dave Zirin, who writes about race and sports often, wrote, "In a league 70% African American, there are now two (!) Black head coaches after today's (firings). Shameful numbers. Failure of a Rooney Rule without teeth and owners who will nearly always bend towards whiteness."

"Not a good look for diversity today in the NFL. In 2006, when Commissioner Goodell was hired, there were seven minority coaches and four minority general managers. Today there are three minority HCs and 1 minority GM after Ozzie retires," wrote Jim Trotter.

The regular season in the NFL ended on December 30. As more
