

## Missing Black Women and **Girls**

**Tawny Reed** 

Type the name Tawny Reed in the Google search engine and click on "News."

In doing so, one will find among the results, an obscure 1960s Welsh singer named Tawny Reed and even a headline from the Telegraph newspaper in the United Kingdom that reads, "The beautiful Turkish wonder you've probably never heard of."

What you won't find is Tawny Reed, the missing 14-year-old Black girl from Reno, Nevada who was last seen on May 1.

It's a recurring theme: An African American female goes missing and there's no radar too low that she won't fly beneath.

The National Center for Missing & Exploited Children- or NCMEC said the number of reports of missing children made to law enforcement in United States now totals more than 424,000.

Tawny stands five feet tall and weighs about 130 pounds and authorities haven't described what she was doing at the time of her disappearance or what she may have been wearing.

Anessa Reed

Less than weeks before Tawny disappeared, Aneesa Reed also missing Reno.

Aneesa [no reported relation to Tawny] is 16 and authorities said she's five-feet and four inches tall and weighs 110 pounds. She was last seen on April 26.

Across the state in Las Vegas, Ashantay Jones,



The Democrats need to pay for a national two-day town hall on this crisis and engage the American people with indisputable facts about his criminal acts and his coverups.


To allow Trump to continue to flaunt his criminal behavior is a shameless reflection on a Democratic Party that is anxious about its political future. For one,

#### **Noble South** There Never was a

Have you ever noticed that when driving through the southern United States you are hard-pressed to find a city or town without a memorial to the Confederate war dead, but you are equally hard-pressed to find a city or town with a monument commemorating fallen Revolutionary War soldiers?

Given the current debate over the removal of Confederate monuments, it might be useful to consider why so much effort has been made to honor traitors who died fighting a losing war against the United States, while so little effort is made to honor patriots who died winning America's independence.

A simple fact, long shrouded by the mist of deceit, explains why traitorous villains have been honored while heroic patriots were ignored.

In the decades following the Civil War,

there was an extraordinary effort by large numbers of white women through the United Daughters of the Confederacy (UDC) to bolster and maintain white supremacy in the South and in the nation. In order to do this, they needed to create a narrative that characterized the Confederate rebellion as a "just cause."

Key to perpetuating the myth of the just cause of slaveholding Southerners was the double-barreled argument combining the notions of the "Noble South," where kindly masters cared for their adoring slaves, and the "Lost Cause," - in which valiant Southern men rose to defend their liberties against an aggressive, greedy Northern industrial complex. Using this logic, the Southern rebellion was characterized as both "noble" and "just" but resulting in tragic heroes fallen in battle and a victimized Southern white populace.

The shorthand for this narrative was projected as the "Lost Cause of the Noble South."

This twisted myth also gave rise to the Ku Klux Klan, celebrated by the UDC as protectors of the white race.

Because of its activities since the Civil War, the UDC currently is considered by the Southern Poverty Law Center as part of the Neo-Confederate movement. And noted historians have considered the UDC to be an advocacy group for white supremacy. But the efforts of these women were so successful that hero worship of the Southern traitors spread into the North.

Not only do eight of the 11 former Confederate states have counties named in honor of Robert E. Lee, but the U.S. Navy named a submarine after him in 1960.

Not only are there roughly 223 public spaces with Confederate monuments in Virginia, a bust of Robert E. Lee and a statue of Stonewall Jackson also were in the Hall of Fame for Great Americans at the Bronx Community College in New York City until their removal in August 2017.

In the U.S. Capitol building of the very nation that Robert E. Lee sought to destroy, his statue stands in Statuary Hall where each state is allowed to place statues of two of its most beloved citizens. In 1909, Virginia chose Lee.

The victory of the UDC in the propaganda war has been almost complete for decades. The organization was able to sway American sentiment to revere traitors and enslavers as heroes of American democracy. However, as Dr. Martin Luther King Jr. said: "The arc of the moral universe is long, but it bends toward justice."

In 2018. the governor of Florida signed legislation to replace the statue of Confederate general Edmund Kirby Smith in Statuary Hall in the national Capitolwith one of the famous African American educator and civil rights advocate, Mary McLeod Bethune. And this year, Arkansas' governor signed legislation to replace its Statuary Hall statues of Confederate loyalist, Uriah Milton Rose and white supremacist James Paul Clarke with those of musician Johnny Cash

and civil rights activist Daisy Lee Bates.

North Carolina and Alabama also have begun removing white supremacists from Statuary Hall.

Confederate statues also have been removed from public spaces throughout the South, including cities in Alabama, Florida, Kentucky, Louisiana, Missouri, North Carolina, Tennessee and Texas. Virginia would be wise to follow suit.

Racism and white supremacy are not going away anytime soon. And as long as organizations like the UDC are around, eliminating these cancers from the American body politic will be difficult and painful.


Nine states of the former Confederacy still celebrate holidays commemorating the attempt to destroy the nation in order to maintain slavery and white supremacy.

Many white individuals continue to disrespect African Americans and downplay the blistering harm caused by centuries of slavery and racism. This was made clear when a racially insensitive photowas discovered on Virginia Gov. Ralph S. Northam's medical school yearbook page. The photo shows one individual in blackface standing next to another individual in a Ku Klux Klan robe and hood.

Gov. Northam first apologized for the photo, but the next day denied knowing anything about it. 



# A New Plan to Make Wall Street Pay for Creating the Foreclosure Crisis

(TriceEdneyWire.com) - Last week, as Rep. Maxine Waters, D-Calif., con-

vened a House Financial Services Committee hearing, featuring the CEOs of Wall Street's biggest banks, the financial watchdog group Better Markets released a stunning report on the banks' criminal records: Wall Street's Six Biggest Bailed-Out Banks: Their RAP Sheets and Their Ongoing Crime Spree

The report profiled the records of Bank of America, Citigroup, Goldman Sachs, JPMorgan Chase, Morgan Stanley and Wells Fargo. Detailing the staggering \$8.2 trillion that was committed to bail out these banks when their excesses blew up the economy in 2008, the report laid out what it called their RAP sheets — the record of illegal activity for which they have been fined a cumulative total of \$181 billion in over 350 major legal actions.

The report concludes that these big banks "have engaged in — and continue to engage in — a crime spree that spans the violation of almost every law and rule imaginable. ... That was the case not just before the 2008 crash, but also during and after the crash and their lifesaving bailouts. ... In fact, the number of cases against the banks has actually increased relative to the pre-crash era."

The scope of the illegal activity is breathtaking overcharging soldiers on their mortgages, conspiring to fix the price of credit card fees, massive improper foreclosure practices, billing customers for services never provided, rigging interest rates, violating sanctions against countries like Iran, and more. The large fines are, for these mega-banks, merely a cost of doing business. And so the crime wave continues.

The banks particularly prey on the vulnerable, regularly pleading guilty of discriminating against African Americans and Latinos. Long after the bailout, for example, JPMorgan Chase paid \$53 million to settle charges that it had discriminated against minority borrowers by charging them more for a mortgage than white customers.

The banks were at the center of the housing bubble and its collapse. About 10 million people were displaced from over 4 million homes across the country. Minority neighborhoods were hit the hardest.

For decades, the banks red-lined minority areas, depriving residents of access to mortgages or loans for small business development. Then, when the banks inflated the housing bubble, they targeted minority neighborhoods, peddling predatory mortgages to customers

who they knew could not afford them. As one former Wells Fargo mortgage broker explained in a sworn affidavit, "The company put 'bounties' on minority borrowers. By this I mean that loan officers received cash incentives to aggressively market subprime loans in minority communities." At the height of the rapacious lending boom, nearly 50 percent of all loans given to African American families were deemed "subprime." The New York Times described these contracts as "a financial time bomb."

When housing prices cratered, the bomb exploded. Mass evictions left entire neighborhoods scarred by empty houses. The banks then failed their legal duty to keep the homes up, with neighborhoods turning into waste pits. With homeowners evicted, local revenues declined. Stores were shuttered; schools closed; local services decimat-

ed

Those victimized were most often those who did the right thing: working steadily, putting together the money for a down payment on a home for their children. A rising African American middle class was eviscerated. In 2012, the National Fair Housing Alliance reported that African Americans suffered "the largest loss of wealth for these communities in modern history." Between 2009 and 2012, African Americans lost just under \$200 billion in wealth, bringing the gap between white and black wealth to a staggering 20:1 ratio.

According to the Better Markets report, the six biggest banks have paid over \$181 billion in fines and settlements for their criminal activity. This money generally goes back into the general fund, unless the settlement agreement

## Prostate screening is a must!!!

My friend Alan ended his four-year battle with prostate cancer, and I started my war to engage Black men and make them know the importance of prostate cancer screening. Though Alan and I have been friends for 30 years, when he got cancer, we formed an even more special bond. As a Stage 3A Survivor of Triple Negative Breast Cancer, I know my purpose is to talk about breast health. I am now adding prostate screenings to my stump speech.

At age 55, Alan had a prostate cancer screening test, the PSA. It was normal. Two years later, it had inched up to the top of the normal range. Although, he was getting annual physicals, his Caucasian, very wellregarded internist in their very affluent suburban town told him that PSA testing was not reliable (this is not true!), and he didn't recommend them.

Life went on, a very good life, full of love, laughter, dancing, a blossoming family. Alan led an exceptionally physically fit lifestyle. He had been a disciplined runner since he was in his 30's and engaged in other types of fitness activities such as lifting weights and tennis.

Following his 70th birthday celebration, he had a visit

brother-in-law who was being treated for prostate cancer. When brought to Alan's attention, he realized that he was having some symptoms (changes in urination). Alan's wife, Yvonne, then insisted he bypass his internist, and they went to a local urologist who told him his PSA was 149.9, shockingly high. Because of the high number, he sought the best care possible and ended up with the Chief of Urology for a major NY hospital. His PSA just 3 weeks later registered at 180. Stage 3B prostate cancer was the diagnosis, which began a path of treatment. He started with Lupron, 10 weeks of radiation, 5 days a week, driving from his home in Ridgewood to Manhattan and then to his office in Morristown, NJ, to work all day as a Chief Investment Officer, a grueling daily regime.

His PSA went down for a short time and then began to increase. Despite chemotherapy, intense immunotherapy. including participation in 2 clinical aggressive trials, the cancer spread throughout his body. Despite the pain and anguish of debilitating cancer, Alan lived his life to the fullest, welcoming a new grandbaby 9 weeks before he passed and signing his favorite song, "My Way"



from his hospice bed.

According to the American Cancer Society, Prostate cancer is the second leading cause of cancer death in American men, behind lung cancer. African-American men are twice as likely to develop prostate cancer and twice as likely to die from it. Research indicates that prostate cancer is not an equal opportunity disease. Black men in the U.S. have substantially higher prostate cancer incidence and mortality rates than the general population. They are also more likely to be diagnosed with an

treated with surgery and radiation therapy. Yet, black men are less likely than white patients to seek treatment, and when they do, their doctors are more likely to recommend a watch-andwait approach over surgery or radiation therapy. When diagnosed early, prostate cancer is treatable!

And note that the disparity in health care happens at all socioeconomic levels. Alan had good health insurance and doctors with good reputations.

Was Alan's struggle with prostate necessary? Could this have been prevented had he been screened more frequently? Would there have been a different outcome if he had been going to an African American physician?

We know Alan would have taken different actions if he had been made aware of the high incidence of prostate cancer among Black men and the benefits of PSA

African American men do and should have different screening recommendations where screening begins at age 40, rather than age 55 for a white man without a family history of the disease. Heed this warning. Don't let distrust of the healthcare system or a Caucasian doctor that doesn't make prostate cancer screening s priority stand in your way. Get screened regularly and live your life to the fullest!


After the dancing was the award ceremony when all the awards were presented culminating with crowning if Miss Debutantes 2019.



**Dear Mr. Brown:** I have noticed more and more people are turning to cremation as a means of funeralizing their loved ones. Can you explain to me the different methods in which the cremation can take place and what are the advantages of the cremation versus the traditional burial in a cemetery?

Robert H.

Dear Robert: You are very observant. The death rate has not changed, however the rate of cremations has due to the squeeze on the economy. Firstly, it is more economic to cremate, which will delete the major purchases of a casket, vault and burial space. The less expensive way of cremation is a direct cremation without embalming and preservation of the body and no viewing or services other than a legal identification of the body. This service can be performed under nine hundred dollars. The next in succession would be a direct cremation with memorials services, which the memorial services can be done by the funeral home or by the family in the manner in which they choose. Some families are setting memorial sevices at the favorite place of the deceased person and some even in their own living room or backyard and weather permitting in the park . Next in succession would be having a funeral service as usual, with the prepared body present using a rental casket and cremating after the funeral service. Then of course the option of a full funeral service is never out of the equation of funeralizing with an earth or mausoleum interment. The traditional burial will give the survivors a place to go in the future to express their love in a pensive manner.

provides for some relief to those injured.

That too often leaves those most injured by the illegal practices out in the cold. What would make sense is that any fines that aren't used to recompense the direct victims be put into a fund to rebuild the communities most injured. Supplement that with revenues from sensible taxes on the banks - like Elizabeth Warren's call for a simple corporate tax on the profits they report and a multibillion-dollar fund could be created to help repair the communities most impacted by the bankers' crimes. Use that money not to line the pockets of the big banks again, but to seed community banks and cooperatives, to support nonprofit affordable housing development, to create postal banking services that could liberate the poor from the usurious charges of payday lend-

That might not end Wall Street's addiction to crime, but it would help repair the communities that they have devastated. One would think that law-and-order conservatives might support this act of simple justice.

church when Trayvon was being laid to rest. My body and heart were numb. People

telling me everything would be ok, and Trayvon was in a better place, but Fulton said.

She said if you haven't lost a child to gun violence, then it's hard to understand what a grieving mother is going through. Losing a parent, a grandparent or other family member isn't the same, Ms. Fulton said. "I lost a grandparent, and the pain was bad, but it doesn't compare to losing a child," she said.

Trayvon's death had her very depressed, and contemplating suicide, she shared with the audience.

Ms. Fulton then asked who lost a child to gun violence, and six women stood up. Ms. Fulton told them they should talk to one another. "Ultimately, you are going to be the only one to make yourself feel better. You have to pull yourself out of that hole," Ms. Fulton said.

She said one of the ways she helped heal herself was getting involved in community. Help organizations, vote, or run for political office, Ms. Fulton said. In fact, she's running for district office in Miami-Dade County, Florida. In her fight across the country against injustices perpetuated against African Americans, one myth Ms. Fulton wanted to dispel about herself was the fact she is against police.

"My father retired as a police officer. I'm not against all police, only bad ones," she said.

After her talk, Ms. Fulton answered questions from the audience.

Mia Reid, a clinical mental health therapist, who lost her son, Charles Reid to gun violence in 2011, came from Detroit, Michigan to hear Ms. Fulton's talk.

"Everything she said was inspiring, and on point," Ms. Reid said. She too, said after her son's death she became more active within her community.


If you see a pet in a hot car, act quickly to try to locate the owner. He or she is likely in a nearby establishment. Talk to the proprietors of nearby



I interviewed professionals from the University of Texas at Austin about how there are an estimated 79,000 child sex trafficking victims in Texas alone," Jeneault said.

"Houston is known to be a hub for trafficking and is unfortunately where black women and girls are roped into the



trade," she said.

It's really quite prophetic that so many African Americans have gone missing and are forgotten [by society], said Phyllis G. Williams, the co-host of Living the Principles Onward. Of course, they will never be forgotten by their

friends and loved ones.

"Malcolm X said the most disrespected person in America is the black woman. The most unprotected person in America is the black woman and the most neglected person in America is the black woman," Williams said.

"This was stated 57 years ago and sadly the words still ring true. Our lack of protection mixed with constant disrespect and neglect contributes to little effort in being found when we are missing," she said.

"Many Americans subconsciously programmed to view women girls as promiscuous, angry, and of little overall value, which leads law enforcement, media and others to reason that there's little need to exhaust the system for someone others believe lack wholesomeness," said Williams, whose family has endured own unsolved disappearance.

"My aunt Doll Crooks has been missing since the mid-1980s and, after more than 30 years, it appears she's just another cold case," Williams said.

"I can't help but wonder if my aunt Doll had blonde hair and blue eyes, while living in an upper-middle class neighborhood, [if] there would have been more detective work [done to find her]," she said
