Activists want local business closed because 'N word' usage

During the evening of November 26, 2019, Alisha, who asked not to have her last name published, told The Toledo Journal, she entered the Sunoco Gas Station, on the corner of Bancroft and Ashland, to purchase several items. When the clerk rang up her total bill, it was much more then she expected. "I asked him, 'Why is the bill so expensive?' He then called me an ignorant 'N word' b. I didn't respond to what he said, and asked him again, why the bill was so high. And again, he called me an ignorant 'N word.' I still said nothing, and again, asked him why it was so much. It was at that time he called me out my name again, and told me to get the 'F' out of his store," Alisha said. "If I was a male, he wouldn't have talked to me like that," she said.

Community activists say the only way the problem can be resolved is if the business shuts down.

filled with people, only one person defended her.

Local activist, Sir Maejor Page, and about a half dozen people, were protesting outside of the business on Saturday, December 7. "We want this business shut down," he said. "I've had numerous people come to me and complain about them overcharging customers, rigging the pumps to which, several cents are already added, before

you start pumping and others reported racial slurs. So their business practices not only affect African American people, but all people who visit it," he said.

Sam Patael, owner of the store, tells a some-

what, different story. He said when Alisha entered the store that night, she was angry about something. "She came in cussing throughout the store, and began

cursing at one of the female employees," who he didn't want to name.

"She began calling the female employee, 'Bs.' Her son, who I don't want to name, was witnessing the entire exchange. He became upset, and called Alisha the 'N word.' He was instantly filled with remorse, and tried to apologize to Alisha, but she refused to hear anything from him, and left the store," Mr. Patael said.

Mr. Patael said the employee is still with the company, but is not working at the moment. He said that particular employee will face further actions.

"We're not racist. The comment was said in the heat of the moment," he said.

Both Mr. Patael, and Mr. Page, said they will have upcoming meetings, but not with one another, on how the situation can best be resolved.

Zaneta Williams details night she was stabbed 12 times, almost set on fire

On the evening of November 4, at the Cedar Ridge Apts., located in West Toledo, Charles Powell Sr. had just returned to his apartment that he shared with his fiancé, and friend of 27 years, Zaneta Williams. He entered into their bedroom, and without warning, explanation, or provocation, Ms. Williams told The Toledo Journal, he began dousing her with fuel from a hand held propane tank. In shock, she repeatedly asked him why he was doing it; Mr. Powell didn't respond. He then tried to lite the tank, to set her on fire, but it wouldn't lite. Ms. Williams said.

She then said, when Mr. Powell couldn't lite the tank, he began hitting her in the head with the handle of the tank. Ms. Williams said she had been trying to flee from him, but he was holding her arm extremely tight, that would later be broken.

Ms. Williams said when she managed to escape her bedroom, trying to leave the apartment, and as she made her way into the living room, she noticed Mr. Powell had covered the entire living room

with propane fuel, as if he was going to set the apartment on fire.

By this time, her daughter, Ariyanna Lewis, 21, who was in the bathroom bathing, had exited the bathroom to come to her mom's defense. With Mr. Powell being physically larger, he was able to ward off the help Ms. Lewis tried to provide to her mom, with multiple blows to her person.

It was at that time Mr. Powell began using a large hunting knife to continue his attack on Ms. Williams. Once in the upper breast, once in her back, once in her lower left lung, once in the groin area, then seven times in the abdomen, which would cause her intestines to hang out of her body, would be the method he utilized to continue his onslaught.

The attack started in their apartment, but would ultimately continue down a flight of stairs, and into the parking lot where Ms. Williams was attempting to head to her vehicle to escape the attack.

"I noticed the hood to my van was up, and wires pulled out, as if he wanted to make sure I couldn't get away from him," she said. The noise from the at-

tack had caused neighbors to call the police. Ms. Williams had fallen to the ground, and her daughter was with her screaming for help, and telling Mr. Powell to stay away.

When the police arrived, Ms. Williams was till conscious, and could see Mr. Powell swinging a sword as the police approached. She said she could hear police telling him to drop his weapon, which ultimately, he did.

From November 4-18, Ms. Williams was hospitalized, and in a medically induced coma. Three surgeries on her abdomen, three reconstructive surgeries on her arm, which Mr. Powell had crushed, reconstructive surgery in her groin region, surgery for her collapsed lung, and crushed fingers, all in a two week time.

From November 18-24, she was in a nursing home rehabbing.

"My family and medical personnel told me they were surprised I survived; no one thought I would make it," Ms. Williams said.

Although she knew her former fiancée had two

prior domestic violence convictions, it wasn't until after the attack that she would find out in detail about those convictions.

Ms. Williams also said that, during their one year engagement, Mr. Powell never physically attacked her.

But as she reflects, she said her advice to any woman would be, "Look for warning signs. My warning signs were the fact he had prior domestic violence convictions, and he was too clingy. He also wanted me to install a GPS app in which he could track my movements. At first, I agreed, but then said no."

"If your prospective mate has prior domestic violence convictions, or a history of domestic violence, no matter how long ago, and if they began to behave strangely, like to possessive, or too clingy, or want you to do something out of the ordinary, those are red flags, and you should stay away from him," Ms. Williams said.

Charles Powell Sr. is in the Lucas County Jail awaiting trial. He's charged with attempted murder on Ms. Williams, and felonious assault on Ms. Lewis.



Poison Ivy For White Politicos:

(TriceEdneyWire.com) - Billionaire Mike Bloomberg entered the already-crowded Democratic presidential primary with a splash. His ad buy of about \$35 million represents more than half of what the other dozen or so candidates have spent on the campaign so far. His \$54.6 billion net worth (according to Forbes) means he has deep pockets and virtually unlimited funds to spend on a campaign. Some think that he can beat Trump in an election since Bloomberg is far wealthier than him. In addition to his wealth, he's white and male. Facetiously speaking, what's not to like?

Except. In his 12-year tenure as Mayor of New York City, Bloomberg was an ardent proponent of "stop and frisk," the policing policy that allows officers to stop virtually anyone without a warrant if they seemed "suspicious". At its peak, more than 650,000 were detained in a single year. Nearly six million New Yorkers were "stopped and frisked" between 2003 and 2015. The overwhelming majority of those who were stopped - 90 percent -- were African American or Latino. In about 85 percent of the cases, there were no fines or convictions.

Civil rights organizations and many others vehemently opposed "stop and frisk." Hundreds thronged to Bloomberg's Upper East Side home to protest the policy. But the then-Mayor was adamant that "stop and frisk" was justified, and explained that more Black and Brown people were being stopped because more of them were committing crimes. But the era of "stop and frisk" was an era where any Black or Brown person, regardless of their appearance or status could be stopped.

Oldest Black-Owned Bookstore in the Country Founded 60 Years Ago is Still Thriving

Marcus Books, based in Oakland, California, is known as the nation's oldest Black-owned bookstore. Founded by the Richardson family in the 1960s, the establishment is still going strong and is still very relevant in the publishing world, allowing Black history and creativity to be recognized and preserved.

Dr. Julian Richardson and his wife Dr. Raye Richardson established what was initially called Success Book Store in San Francisco's Fillmore district inside their printing shop. It was eventually named Marcus Books in honor of the political leader and publisher, Marcus Garvey.

Their children now manage the family-owned bookstore. Karen Johnson, their daughter, said his father has always wanted to open a bookstore "for and by Black people." And even though some of their bookstore locations were closed due to rising rents, they are proud that the Oakland location is still thriving.

Some of their loyal patrons include educators who are finding books that are usually not available in larger publishers as well as new authors who are interested in having their books on the shelves of Marcus Books.

"I've known about this place since college," said new author Daud Jadi. "For me it was a natural thing, a natural progression, to come here first because if I can get my book in Marcus Bookstore then I've accomplished something in my life."

Meet Maggie Lena Walker, the First African American Woman to Own a Bank

In 1903, Maggie Lena Walker founded St. Luke Penny Savings Bank in Richmond, Virginia making her the first African American woman to charter a bank in the United States. Her bank not only focused on adult clientele, but also marketed to children and encouraged them to save their money.

From the beginning

Walker was born on July 15, 1864 in Richmond to parents who were slaves. During her early years, her father died and she had to help her mother financially by working.

In 1902, however, she had become a journalist and began writing for the The St. Luke Herald where she encouraged African Americans in Richmond to harness their economic power Her bank not only focused on adult clientele, but also marketed to children and encouraged them to save their money.

by establishing their own institutions. She focused her efforts on accounting and math, and as a result, she established her first business which was a community insurance company for women.

Just one year later, she had established her own bank, and in 1924, St. Luke Penny Savings Bank began attracting customers from other parts of Virginia. During the Great Depression when other banks collapsed, her banks managed to stay afloat.

More than just a business woman

Walker was very active in civil rights organizations like the Association National of Colored Women (NACW) and the National Association for the Advancement Colored People of (NAACP), where served as the Vice President of the Richmond chapter.

As for the fight for rights, she fought arduously for women's rights as well and served as a board member for the Virginia Industrial School for Girls.

Sadly, she died on December 15, 1934 due to diabetes complications, but her bank eventually consolidated with two other large bank and moved to downtown Richmond. It is still in operation today!

A few of those who should not have been stopped sued. Many protested. Some considered 'stop and frisk' the byproduct of racism and racial profiling and chose not to take the legal route. The era of stop and frisk exacerbated tensions between "law enforcement" officers and the Black community. And until recently, Mayor Bloomberg stood by his stop and frisk policy.

Then a week before his entry into the contest for President, Bloomberg "apologized" for the stop and frisk policy, speaking at an African American megachurch in Brooklyn, New York. His very cynical use of the Black church, along with the timing of the socalled apology, is highly suspect. And the decade-too late apology, offered with no remedy, is meaningless.

The very wealthy Mr. Bloomberg could accompany his apology with a sizeable donation to criminal justice reform. He could break off a few million and donate it to the NAACP Legal Defense and Education Fund, the LatinoJustice PRL-DEF, the American Civil Liberty Union, or any of the other organizations fighting for criminal justice reform. An apology, without an offer to redress the wrong, is meaningless. A simple apology, especially after all the harm that was done, is as sorry as the words "I'm sorry." Sorry doesn't always make it right.

The apology seems to have been made to aid the Bloomberg presidential campaign, but most people won't be fooled. Despite his money, Bloomberg is a late entry into the race. His wealth is the only thing that makes him stand out, but not by much, since there is another wealthy white man – Tom Steyer – in the race. Some say it takes a big person to acknowledge their wrong, but Bloomberg left office in 2013. He's had at least six years to apologize. In the years since Bloomberg left Trigger-happy cops have killed too many Black and Brown folks. Do the names Tamir Rice, Philando Castille, or Michael Brown mean anything? If Mayor Bloomberg were sorry, he could talk about the flaws in our criminal justice system.

office, tensions between Black and Brown citizens and police officers have risen. Trigger-happy cops have killed too many Black and Brown folks. Instead, he has offered a half-baked apology without acknowledging or attempting to remedy, the impact his unjust policies had on Black and Brown lives.

The current President is proof positive that money, integrity, and sagacity are not positively correlated. Bloomberg's tepid apology may be further evidence that the wealthy don't think the rules apply them. Mike Bloomberg clearly has money to burn, but it would be great if he burned it for criminal justice reform than for an ill-fated, vane, presidential campaign.

Healthcare for All: An Oxymoron?

(TriceEdneyWire.com) - "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness" - The Declaration of Independence

Ask anyone what the one topic that seems to be on the lips of all the Democratic Presidential Candidates, and they will answer: Healthcare for All.

But few of us have really stopped to think about who All is referring to. And how are we defining Healthcare?

Sadly, the focus of the advocates of Medicare for All, is centered on health insurance. But we clearly must take a look at some if the deeper issues. Even having some type of insurance is no guarantee of health status. There are differences in the healthcare provided, and the health status between those with Medicaid, Medicare, private insurance, and those uninsured. I think we all know better to think that any of the proposals by the candidates is suggesting that Healthcare for All will mean that everyone will receive the same care. It ain't gonna happen!

Somehow, the most disadvantaged within the healthcare and medical system in this country have allowed this conversation to take place at "30,000", forgetting about the barriers, obstacles, and bias that impact those on the "ground".

Who are these folks on the "ground"? Children; seniors; the homeless; and of course, people of color – particularly African-Americans.

There are mounds and mounds of research and studies that have conclusively documented that the disenfranchised parts of our society are left behind, if not forgotten.

Here are a few facts that you may need to be reminded of:

According to the American Academy

Somehow, we must not forget to mention the 800-pound gorilla in the room. The thing that is central in all of these subpopulations, even more than race: Poverty.

Health disparities are directly associated with higher levels of poverty. The state of insecurity that poverty creates has been demonstrated to cause more mental distress than war, leading to higher blood pressure, increased levels of stress, and drastically higher levels of depression. Mental distress brought on by financial strain can then be passed on to children, leading to poorer health and education outcomes that occur even if an individual's financial state later improves. The experience of poverty at any stage of life may impact individuals' health as they age. It is estimated 14.6 percent of older adults are currently living in poverty. Being raised in poverty puts children at risk for a wide range of problems, including impaired cognitive, social, and emotional functioning, as well as poorer health. Child poverty is also associated with negative outcomes in adulthood.

Blacks and Hispanics often get less effective health care than whites. They often get more unnecessary and economically inefficient care. It holds true from the cradle to the grave. Even at the end-of-life, while 5 percent of white Medicare patients with dementia received a feeding tube, 17 percent of blacks and 13 percent of Latinos did.

For the first time in our history, the United States is raising a generation of children who may live sicker and shorter lives than their parents. It doesn't stop there.

As reported in Time, "Researchers from the New York University School of Medicine recently used data from NYU Langone Health's City Health Dashboard to find that 56 of the U.S.' 500 largest cities are home to people who can expect to live at least 20 fewer years than those in other neighborhoods, even if they're just blocks or miles away".

That's right. Where you live can determine how long you live. In fact, right here in Philadelphia, you will die 20 years sooner if you live in parts of North Philadelphia, than you would if you lived in Rittenhouse Square (location of the infamous Starbucks incident).

If we are to make it possible for everyone to enjoy "life, liberty, and the pursuit of happiness" as promised in our nation's founding documents, then we must take an honest and objective look where we are falling short, and demand that the words in the Declaration of Independence ring true: That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, - That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Ask Rusty Using a Restricted Application to Maximize Benefits

Dear Rusty: I was born on 1/14/1953, and my wife was born on 6/27/1954. I will have the largest Social Security benefit by 2 or 3 to one. She has been retired for a year or so, but I am working part time. We planned on not taking our SS until 70, since my IRA and Social Security will cover us until 90plus. I want to maximize my SS benefit in case we live past then. I have read about a restricted application and file and suspend, but I get conflicting information on who must be born before 1/2/54. Is there anything we can do besides wait to 70 to maximize our benefits? Signed: Wanting to Maximize



Dear Wanting: How you, as a married couple, should plan your Social Security depends largely upon whether your wife will be eligible for a spousal benefit from you and, if so, how much her spousal benefit will be. Your wife will get a spousal benefit from you if her own benefit amount at her full retirement age (66) is less than half of your benefit amount at

your full retirement age (66). The difference between those two amounts will be added to your wife's own benefit (from her own work record) to become her spousal benefit. At her full retirement age (FRA) she would get 50% of the amount you were el-

igible for at your FRA, which you reached in January 2019. If your wife's benefit at age 70 will be more than her spousal benefit will be, then it would be prudent for her to delay claiming until age 70 when her benefit will be 32% more than it would be when she turns 66. However, if her spousal benefit will be more, it could make

In 1996, the U.S. Navy commissioned USNS Henson, a pathfinder/survey ship

named in his honor. At the age of 79, Barbara Hillary reached the South Pole.

Hillary, whose last name briefly remined me of Edmund Hillary, the New Zealand mountaineer who was the first man to climb







sense for your wife to file for her own benefit first, which would allow you to file a "restricted application for spousal benefits only." Your wife cannot file a restricted application because she was born after January 1, 1954, but you can file the restricted application because you were born before that (the "File and suspend" option which allowed your wife to collect spouse benefits while your benefits are suspended is no longer available).

Provided your current finances, as well as your health and expected longevity suggest you can delay, it would be a wise strategy for you to delay claiming until age 70 because it will provide you with the maximum possible monthly benefit and also the most in cumulative lifetime benefits if you attain at least "average" longevity (about 84). This would also give your wife the highest possible survivor benefit should you predecease her (as your widow, your wife gets 100% of the benefit you were

How you, as a married couple, should plan your Social Security depends largely upon whether your wife will be eligible for a spousal benefit from you and, if so, how much her spousal benefit will be.

receiving at your death). Your wife cannot collect a spousal benefit from you until you start your own benefits, but if she were to choose to claim her own Social Security retirement benefit from her own work record first (so you could file the restricted application), she would switch to her higher spousal benefit when you claim.

So, if your wife's spousal benefit will be her highest benefit, as a couple you may wish to consider your wife filing for her own benefit to start in January (will be reduced by about 3.3%) and, at that time, you file a "restricted application for spousal benefits only" which means you will collect 50% of your wife's (unreduced) FRA benefit amount while your own Social Security benefit continues to earn delayed retirement credits (DRCs). DRCs are given at the rate of 2/3rd of 1% per month of delay (8% per year of delay), up until age 70 when your benefit will be 24% more than it would be at age 67. Then, at age 70, when you switch from the spousal benefit from your wife to your own SS retirement benefit, your wife can file for her spousal benefit from you. If you are, indeed, fortunate enough to live well into your 80s, the above will provide you with considerably more in lifetime benefits than any other strategy you might consider. Along with a distinguished career as a trial lawyer, human rights advocate and United Nations judge, Robertson has appeared in many celebrated trials, defending Salman Rushdie and Julian Assange, prosecuting Hastings Banda and representing Human Rights Watch in the proceedings against General Pinochet.

In his just released book, he scores the British Museum for allowing an unofficial "stolen goods tour", "which stops at the Elgin marbles, Hoa Hakananai'a, the Benin bronzes and other pilfered cultural property". The three items he mentioned are wanted by Greece, Easter Island and Nigeria respectively.

"That these rebel itineraries are allowed is a tribute to the tolerance of this great institution, which would be even greater if it washed its hands of the blood and returned Elgin's loot," he wrote.

He accused the museum of telling "a string of carefully-con-

structed lies and half- truths" about how the marbles "were 'saved' or 'salvaged' or 'rescued' by Lord Elgin, who came into possession of them lawfully."

He criticized "encyclopedic museums" such as the British Museum, the Louvre in Paris and the Metropolitan in New York that "lock up the precious legacy of other lands, stolen from their people by wars of aggression, theft and duplicity".

"This is a time for humility," he observed, "something the British, still yearning for the era when they ruled the world do not do very well. Before it releases any of its share of other people's cultural heritage, the British Museum could mount an exhibition – 'The Spoils of Empire'."

Advocating the return of cultural property based on human



rights law principles, Robertson observes that the French president, Emmanuel Macron has "galvanized the debate" by declaring that "African cultural heritage can no longer remain a prisoner of European museums".

"Politicians may make more or less sincere apologies for the crimes of their former empires, but the only way now available to redress them is to return the spoils of the rape of Egypt and China and the destruction of African and Asian and South American societies," he writes.

"We cannot right historical

wrongs - but we can no longer, without shame, profit from them." 

Meet the First Black Woman to Successfully Climb Mount Everest

In 2006, Sophia Danenberg became the first African American and the first Black woman to climb to the summit of Mount Everest in Nepal, the world's tallest mountain. Since 1953, only about 2,500 people have actually reached the top and more than 300 people have died trying.

But the potentially deadly climb was not at all easy for Sophia. In fact, when she reached the peak, she was suffering from bronchitis, a stuffed nose, frostbite on her face, and a clogged oxygen mask. Nonetheless, she made it to the top and made it back alive.

She has also successful climbed other famous mountains including Mount Tasman (in New Zealand), Mount Kilimanjaro (in Tanzania), Mount Rainier in Washington State, and Mount Kenya (yes, in Kenya).

Also a business woman Sophia, however, is more than just a mountaineer. A graduate of Harvard
