



On Saturday, September 7, 2019, the weather was

and styles of jazz music and it was like the old saying, 'How time flies when you're having fun.' This evidently was the motto for the majority of the audience, who attended the concert, the bulk of the audience stayed for the entire ten hours. It was like a mini version of the Woodstock

# Breaking Barriers in Ballet: Misty Copeland Set to Receive Trailblazer Award

Misty Copeland had the world of ballet standing still, when she

made history as the first Black female principal dancer to the prestigious American Ballet Theatre (ABT) in 2015, just months after becoming PHOTO CREDIT / SUBMITTED the first Black woman to

perform the lead role of "Odette" in ABT's coveted "Black Swan" in the winter of 2014.

Determined to shatter

the glass ceiling of the ballet world, on Sep. 11, the Congressional Black Caucus (CBC) will honor Misty Copeland with their esteemed Trailblazer Award during the CBC's annual "Celebration of the Arts" event—an award that Copeland deemed as not only an honor but also a necessity.

"It's so important for other Black dancers to see a possibility, a future for themselves, in a world that still doesn't include many other Black ballerinas," Copeland said.

"There's definitely still a glass ceiling in the ballet world," Copeland continued. "There's only one Black principal dancer in the American Ballet Theatre in their entire almost 80-year history and a lot of people don't have the understanding that just because it's been done once, doesn't meant that that problem goes away... having one Black president didn't mean that racism didn't exist."

"If I didn't have art in my life, then I wouldn't be the articulate, confident person that I am today. Fields in STEM are important but the arts are also so vital... not every child learns the same way and sometimes the missing link is art."

Growing up as the fourth child of six in underserved areas of San Pedro, California, Copeland spoke to a time where she and her five other siblings found themselves all living in a small motel after her mother's marriage to her fourth husband became abusive both emotionally and physically — to Copeland's mother and

all of her children.

Despite the economic and social hardships, Copeland said that she was able to find solace and her voice through the world of dance. At the age of 13, the ballet lessons that she began taking at at the local Boys and Girls Club would eventually allow her to move in with her teacher's family and eventually prepare her to make history.

"It's been 25 years now that I've been a part of classical ballet and I still have that same fire," Copeland said. "I think for me it was initially out of my own need, as a 13-year old girl growing up in underprivileged areas, to find structure, something I never had, and dance provided exactly what I needed for that time in my life."

"I represent ballet and any child that needs to see someone persevere," Copeland continued. "What it means to be an underdog and to be mentored and have an amazing support system and represent that American dream."

Since joining the American Ballet Theatre in 2001, Copeland has gone on to be inducted into the Boys & Girls Club National Hall of Fame; serve on the President's Council on Fitness, Sports, Nutrition, under Obama administration; publish three books, including the New York Times Bestselling memoir, "Life in Motion;" secure her own clothing line with Under Armour; and receive an honorary doctorate from University of Hartford. All the while Copeland has been an ardent beliver reminding others that "representation is important."

"I'm still a Black ballerina and a Black woman in this world and that doesn't just disappear with titles," Copeland said. "The more I use my visibility, my platform, my voice, to continue to speak about diversity both in front of the scenes and behind them, the more I'll be able to help change the directory of dance."

"A lot of underserved areas and youth either don't receive access to dance courses or don't receive quality training, which limits their chances of going even further when that time comes," Copeland continued. "My hope, is that with my platform, I can continue this conversation to bring about change, to show younger people how to own their own power, to embrace who they are, to walk in their own path and to be represented."

## "Jay-Z" Did Not Sell Out, He Bought In

(TriceEdneyWire.com) - "Power without love is reckless and abusive, and love without power is sentimental and anemic. Power at its best is love implementing the demands of justice, and justice at its best is power correcting everything that stands against love." Rev. Dr. Martin Luther King, Jr.

In the wake of former NFL quarterback Colin Kaepernick's protest against police brutality and extrajudicial murder, Jay-Z's Roc Nation has struck a deal to lead the NFL's endeavors into music and entertainment. This deal has caused a lot of consternation within the African American community. The issue now being raised centers around Jay-Z being a "sellout".

What must be clearly understood is that Jay-Z is a capitalist. He did what capitalists do, he bought in.

Before he was Jay-Z, he was Shawn Carter. He grew up in the Marcy Projects in Brooklyn, NY and was a drug dealer in his youth. By his own admission, his drug-dealing days prepared him for his current life as a sports entrepreneur and music mogul. "I know about budgets. I was a drug dealer. To be in a drug deal you need to know what you can spend." To Shawn Carter, drugs were just a widget or commodity whose sale presented no moral dilemma or conflict. Selling drugs was a means to an end. It's the urban Horatio Alger story, from as he said, "grams to Grammys". Shawn Carter sold out his community for his personal gain by selling drugs to his own people. Jay-Z, the capitalists, has once again increased his personal fortune by buying into an institution that has also shown little regard for the fate of Black people.

When asked where we are in the protest process and the significance of kneeling, Jay-Z gave a very Trumpian response: "I think we've moved past kneeling and I think it's time to go into actionable items... No, I don't want people to stop protesting at all. Kneeling - I know we're stuck on it because it's a real thing - but kneeling is a form of protest. I support protest across the board...But now that we all know what's going on, what are we going to do? How are we going to stop it? Because the kneeling was not about a job, it was about

Translation? Jay-Z supported Kaepernick in the moment because it was the thing to do. Now there is an opportunity to get paid and as a capitalist, I'm about that paper.

In addition to helping the NFL with entertainment, Jay-Z will also consult with the NFL on matters of social injustice. Speaking of injustice...this opportunity for Jay-Z to work with the NFL only became possible after Kaepernick sacrificed his NFL career to protest against the real injustice of state sanctioned murder by the police. If Jay-Z were really down for the cause, wouldn't he have stepped to the mic and told NFL Commissioner Roger Goodell that he will work with the NFL on the condition that "Kap" gets a fair shot at making an NFL roster? He could have used that moment and power to put real pressure on the league.

What must be clearly understood is that Jay-Z is a capitalist. He did what capitalists do, he bought in.

But it's not really about Shawn Carter aka Jay-Z. He is a metaphor. In the current context, Jay-Z is a distraction from the real issue... the dangers of Black capitalism. In Manning Marable's "How Capitalism Underdeveloped Black America, Marable writes, "A decisive component of this underdevelopment process within the periphery is the nonwhite elite." These elite play a very important role. They serve "...as a necessary yet dependent buffer between those who wield power and those who have none. Within popular culture, it is the nonwhite mouthpiece

of the new order, articulating in the media and in the various aesthetic forums the ideals of the masters.'

As referenced in the opening, Dr. King was clear, "Power without love is reckless and abusive...Power at its best is love implementing the demands of justice...' Jay-Z is wealthy and in some circles, wields a certain degree of power. However, given the example set by Kap's protest and sacrifice, what part of Jay-Z's deal with the NFL shows the love for the community and the demand for justice? This deal seems to be power without love, reckless and abusive.

When White capitalists team with Black capitalists, the Black community finds itself in a more precarious circumstance. The White capitalists will leverage the indifference and duplicity of the Black capitalists against the very community that the Black capitalist claims to support. "We don't need to kneel anymore. It's time to get paid." Frederick Douglas told us very clearly, "Find out just what any people will quietly submit to (or get paid to do) — and you have found out the exact measure of injustice and wrong which will be imposed upon them. The limits of tyrants are prescribed by the endurance of those whom they oppress. Power concedes nothing without a demand. It never did and it nev-

By focusing on Jay-Z we are losing site of the fact that Colin Kaepernick used his platform to call attention of historic and systemic problem in America, state sanctioned brutality and murder by the police. The NFL, the government and the media used their power to corrupt the message and demonize Kaepernick, costing him his livelihood.

As was the case with Curt Flood, Muhammad Ali, Dr. John Carlos and others before him, Colin Kaepernick will eventually be remembered for taking a stand, or in this case, a knee for justice.

Jay-Z will be remembered for buying in...and by buying in, he sold out.



## Violent White Supremacists Continue to Threaten Basic Civil Rights — and Our Lives

(TriceEdneyWire.com) - Every right we have fought for and won since Dr. Martin Luther King Jr. delivered his monumental "I Have a Dream"speech 56 years ago this Wednesday is under unrelenting attack and in grave peril — from the right to drink fresh water and breathe clear air, to the right of workers to organize for better wages and safer conditions to the right to vote without interference from "enemies foreign and domestic" to the rights of women, children, the LGBTQ community and immigrants.

But it's not just our rights that are in danger. It is our very lives. Today, when demagogues like Trump fan the fears of an "invasion" of Latinos and Blacks that he believes will erode White dominance, White

supremacist violence is once more on the rise. After the horrendous mass shooting in El Paso, Texas by a White supremacist — who drove more than 600 miles to the city with the explicit purpose of slaughtering Latinos in response to the mythical "invasion" President Donald Trump and the right ranted about - new attention has been paid to the growing violence of White supremacists. In the few weeks since El Paso, six White supremacists have been arrested for plotting violent attacks.

The Anti-Defamation League reports that White extremists killed 50 people last year — people of all races. Some compare the threat posed by White supremacists here at home to the terrorist threat posed by ISIS

## 102 House Members Rebuke Delay of Payday Loan Rule

## Waters Led Effort Supported by Many CBC Members

(TriceEdneyWire.com) - Anyone who struggles with the rising costs of living knows all too well how hard it is to try stretching dollars when there's more month than money in the household. Predatory lending, like payday and car-title loans, worsen financial stress with triple-digit interest rates that deepen the debt owed with each renewal.

The irony is that many payday loan borrowers who needed just a few hundred dollars wind up owing thousands. And any loan whose accrued interest exceeds the principal borrowed, is truly predatory.

In recent days, more than 100 Members of Congress stood in support of consumer protections against these debt trap loans. The effort, led by House Financial Services Chairwoman and California Representative Maxine Waters, called upon the Consumer Financial Protection Bureau (CFPB) to do two things: stop delaying the current rule from taking effect, and preserve the existing rule's requirement that lenders only make loans to consumers whom could afford repayment.

The August 23 letter to CFPB minced no words.

"Experts have noted that payday loans often target communities of color,

military servicemembers, and seniors," wrote the Members, "charging billions of dollars a year in unaffordable loans to borrowers with an average annual income of \$25,000 to \$30,000."

"The Consumer Bureau's proposal represents a betrayal of its statutory purpose and objectives to put consumers, rather than lenders, first," continued the Members. "Moreover, the Bureau has offered no new evidence and no rational basis to remove the ability to repay provisions. We think you should immediately rescind the harmful proposal to roll back the 2017 payday rule."

These direct rebukes were reactions to CFPB's 15-month delay of a long-awaited consumer-friendly rule that was scheduled to take effect on August 19.

In today's contentious Washington, getting strong support for any pro-consumer issue seems particularly difficult. Even so, the August letter to CFPB Director Kathleen Kraninger included Representatives from 31 states, including those with some of the highest annual percentage rates found across the country. For example, the typical payday loan in California comes with 460 percent interest and the largest number of state signatories also came from California: 15.

Although no other state's signatories were that numerous, the clear expression of genuine consumer protection against this heinous predatory loan in other areas with rates near or exceeding 400 percent is noteworthy: Texas (661 percent), Wisconsin (574 percent), Missouri (462 percent), and Illinois (404 percent).

Yet a closer examination of the signatories reveals that despite sizeable support expressed in the letter, there are still 435 officials in the House of Representatives. The recent letter represents about 23 percent of the entire House. That small percentage signals that many more Members of Congress

need to make clear that they stand on the side of the people – and not with payday lenders' 400% interest rates.

Across the country, communities of color are where payday and car-title loan stores are the most prevalent. Among Congressional Black Caucus members serving in the House, 58 percent added their names and support to this important letter.

New research on the nation's wealth gap by McKinsey & Company found that 65 percent of Black America lives in one of 16 states: Alabama, Arkansas, Delaware, Florida, Georgia, Illinois, Louisiana, Maryland, Michigan, Mississippi, New Jersey, New York, North Carolina, South Carolina, Tennessee and Virginia.

Among these 16 states, only Arkansas, Georgia, and North Carolina have enacted 36 percent or less payday loan rate caps. The remaining 13 states have typical triple-digit payday loan interest rates that range from a low of 304% in Florida to a high of 521 percent in Mississippi. Multiple CBC members also represent districts in these states.

Speaking at a House Financial Services subcommittee hearing held on

April 30, Diane Standaert, an EVP and Director of State Policy with the Center for Responsible Lending testified of the rippling reasons that payday loans need regulation.

"Allowing the 2017 rule to go into effect as planned is the bare minimum that the CFPB should do," said Standaert. "It is absurd that we should even have to make such a straightforward request of an agency whose charge is to protect consumers from unfair, deceptive, and abusive financial practices"

Rev. Dr. Frederick Douglass Haynes, III, Senior Pastor of Dallas's Friendship West Baptist Church also testified at the April hearing.

Said Rev. Dr. Haynes, "Payday predators hijack the hopes of the vulnerable and re-victimize them by baiting them into a debt trap...It is reprehensible that there may be a plan to open the way for old bank payday loans to re-enter the marketplace, as well as predatory high-cost bank installment loans."

## Violent White Supremacists Continue to Threaten Basic Civil Rights — and Our Lives

or al-Qaida. What too often is overlooked, as MSNBC commentator Chris Hayes noted in his show last Friday, is that White terrorist violence has been part of the American experience from the beginning. Hayes notes that the first real terrorist cells in the U.S. arose after the Civil War as a response by White southerners to the freeing of slaves. When slaves became free men, the power of the White establishment in the South was threatened. The reaction was violent — with community leaders joining to create terrorist cells — most of which became known as the Ku Klux Klan.

To preserve White dominance, the Klan launched a wave of terror against Blacks and their White allies across the South, including lynching, murder, abduction and rape. Hayes cites the 2,000 murders in the state of Kansas in the lead-up to the 1868 election, designed to terrorize potential Black voters, with the explicit aim of sustaining White power.



When Ulysses S. Grant became president, Congress passed legislation in 1870—theEnforcement Acts—that empowered the federal government to respond to the wave of terror. For the first time, the newly created Department of Justice began prosecuting the Klan in federal courts, backed by federal troops on the ground in the South. They made great progress

against the Klan until a political compromise that led to the withdrawal of federal troops and the reassertion of states rights." That opened the floodgates to a wave of terrorist attacks launched by the Klan and others against Blacks that enforced apartheid across the South.

White terrorism goes hand in hand with slavery. White slave owners were in constant fear of slave revolts and on constant guard against slaves running away to seek their freedom. Slave patrol militias — made up of volunteers from the leading slave-owning families of the South — were created to police the plantations, to track down runaway slaves and to put down any insurrection. Again, violence — from whipping to murder — was employed routinely by the slave patrols.

The Second Amendment — the right of people to join militias and bear arms — was added to the Constitution in large part to protect the right of slave owners to sustain the slave patrol militias. In 1788, when Virginia met to consider ratification

of the Constitution, slave owners attacked the Constitution for giving the federal government the right to organize militias.

At the time, slaves outnumbered the White population in much of eastern Virginia. James Madison wrote the Second Amendment largely to protect the rights of slave owners to enforce the reign of terror against slaves in the South. It had nothing to do with the right of individuals to bear arms, because Blacks—free or enslaved—were prohibited from owning and bearing arms across the South.

As Hayes argues, when the federal government acts to condemn and to prosecute this domestic terrorism, it can largely stamp it out. But when it fans the flames or turns its back or leaves it to the states, that terrorism can easily get out of control. Today, America is still wrestling with how and whether it will grow out of its racial divides. By fanning the flames of those divides, Trump is dangerously choosing to feed an increasingly violent White supremacist reaction.

## UToledo breakthrough in how cells link together has implications in the proliferation of cancer

For cancer to be successful — from its point of view, anyway - the disease has to find a way to break out beyond its initial foothold and spread throughout the body. Newly published research from The University of Toledo could bring fresh insight into one of the first ways cancers proliferate.

Dr. Rafael Garciaan associate Mata, professor of biological recently sciences. identified protein complex that regulates together in such tight connections.

There are more than 150 different types of epithelial cells that carry out essential functions in a wide variety of tissues. Those jobs include making our skin resilient, producing the mucus that lines and guards our airways, and helping with the absorption of nutrients in our digestive system.

The discovery, which builds on Garcia-Mata's research focus of how cancer cells spread

how epithelial cells bond throughout the body, is intriguing because it explains the behavior of cells that are by far the most common starting place for cancer.

> "Eighty percent of cancers originate from epithelial cells and most cancers will have to disassemble the adhesion system to grow and spread," Garcia-Mata said. "If we understand how these adhesive structures are built, we can also try to understand happens when cancer cells disassemble

His research was published June 27 in the Journal of Cell Biology.

Epithelial tissues line the outer surfaces of organs and blood vessels throughout the body, as well as the inner surfaces of cavities in many internal organs. Their ability to form nearly impermeable junctions enables them to establish boundaries that separate the inside of organs and other tissues from the outside environment.

## Diabetes Makes Disaster Planning Even More Important

Submitted

(NAPS)—Everyone should plan for natural disasters, but this planning is especially important if you have a chronic health condition such as diabetes. Follow these nine steps to be ready:

1. Do basic planning. Plan for where you will go if you must leave home, how you will get there and who will meet you there. Stay current with your vaccinations. Contact your county emergency management office for advice on transportation and other services for with special people needs.

2. Pack a go-kit. In a waterproof container, pack first aid supplies including antibiotic cream, a flashlight and spare clothes. Include extra socks and shoes, because it's important to keep your feet dry and free of infection. Keep on hand for quick packing a week's worth of medicine plus supplies, medical equipment, spare equipment batteries and cash. If you use insulin, store it in the fridge with an insulated lunch bag nearby, ready to fill and front door.

3. Put information folder in your kit. This should include contact information your healthcare professionals, pharmacy and emergency contact person; a list of your medicines, doses and dosing schedules; and the make, model and serial number of any medical device you use in case you need to replace it. Also include copies of recent A1C results or other lab work, your health insurance card and your photo ID.

4. Include food supplies in your kit. Pack a three-day supply of water and nonperishable foods that fit with your meal plan. Include snacks to treat low blood

5. Wear a medical alert ID. Ask your healthcare professional about how to get a free tag that states your medical condition. This is important if you need medical care but are not in a condition to talk.

6. Do kidney care planning. If you are on dialysis for kidney disease, which often cooccurs with diabetes, talk

If you have a home dialysis or peritoneal dialysis machine, plan for how to power it if the electricity is out and how to stop dialysis if you lose power in the middle of a treatment. Register with your water and power companies for priority service restoration. In your information folder, keep a copy of your dialysis treatment plan, the phone numbers of your dialysis center and other nearby centers, and the kidney community hotline at (866) 901-3773. 
Additional NPM Actions for Emergency Preparedness:

- Organize disaster supply kits for your home and vehicles. A supply kit is a collection of basic items your household may need, in the event of an emergency. Most items in a basic kit are inexpensive and easy to find. And you might already have a lot of the items in your home. After a disaster happens, you may need to survive on your own for several days. Your disaster kits should have enough food, water, and other essential items to sustain everyone in your home (including pets) for at least three days.
- Take time to learn life-saving skills actions you can take to prepare for and protect against disasters and severe weather events. Install smoke, carbon monoxide and natural gas detectors, and test them

monthly. Know how to turn off utilities, like water and gas. Talk to your landlord or building manager about evacuation routes and fire safety. Know two ways out of your home in case of a fire and practice evacuation plans.

- Check your insurance policies and coverage for the hazards that might impact your home or community, such as flooding, tornadoes or home fires.
- Consider the associated costs with disasters. Consider saving money in an emergency savings account that could be used in any crisis. Keep a small amount of cash at home in a safe place. Have small bills on hand because ATMs and credit cards may not work after a disaster when you may need to purchase necessary supplies, fuel or

controls a lot of the properties that make the 'right' epithelial tissues," Garcia-Mata said. "Understanding how they normally function allows you to understand what happens when things go wrong."

The implications of these findings go well beyond cancer. Garcia-Mata's research also helps explain how cells coordinate to generate organ cavities, which may broaden our knowledge of early development and organ formation. It could add significant new pathways for explaining conditions such as asthma and inflammatory bowel disease.

"A lot of diseases are essentially leaky epithelia. Understanding how these structures are modulated may help us learn why we get some of these diseases," he said.

Garcia-Mata's research into epithelial cells grew out of prior National Institutes of Health grant-funded work investigating how cancer cells spread away from the primary tumor.

"My lab studies basic, hardcore cell biology. This is where we make discoveries that lead to our ability to understand and target particular diseases, and the initial event in most cancers is the disassembly of these epithelial structures," he said.

in to weather reports and listen for what local leaders say about evacuation. Keep your phone and any medical devices charged. If you have a car, keep it gassed up.

8. Evacuate early. As soon as local leaders advise people to evacuate, go to your preplanned location. Don't risk being trapped without access to electricity, clean water and supplies. Plus, early evacuation gives you a better chance of being

housed in a special-needs shelter. When you arrive at a shelter, alert workers about your health conditions so you may get the support you need.

9. Update your plan and restock your kit. At least once a year, review your emergency plan with your doctor. On an ongoing basis, swap out items with expiration dates.



## Bishop Frank M. Reid III to preach Friday revival hosted by Methodist Ministers



For more than a decade, "The Bethel Outreach of Love" was broadcast on Black Entertainment Television. It was also on The Word Network, the Armed Forces Network, as well as on international stations.

The Right Reverend Frank Madison Reid was assigned early this year to the Third Episcopal

Methodist District - which covers Ohio, West Virginia, and Western Pennsylvania by the Council of Bishops of the AME Church following the January death of the district's previous Presiding Prelate, Bishop McKinley, who was senior bishop of the church.

Bishop Reid knows that our region, like so many across the nation, not only needs help, but that residents everywhere desperately need hope. He will absolutely inspire people and remind them that hope is not difficult to find, as it is not far, that it is easy to embrace, and that it is life changing. 

## **Traffic Court Legal Tips**

Ok. This is where I put on my legal wig and pontificate about the "system" and the people, wittingly or unwittingly, who are caught up in it, for good or for bad.

Doing this legal thing for more than four decades (how time flies when you are having fun!), I have had endless opportunities to watch both other attorneys'

client's being sentenced and my own clients being sentenced.

The following ruminations are not client specific but are a general observation of what people do or should not do when they enter the legal system and stand before a judge.

I want to limit my remarks to the bizarro world of traffic sentencing including Toledo. Maumee, Sylvania and

other municipal courts that are engaged in processing people who have broken the law.

I use the word, "bizarro" to capture the flavor of what people say to their attorneys or to the magistrates or to the judges when they are asked to either make statements before the gavel is lowered on them or in the hopes that their statements will shed some light on their conduct; and thus result in a lighter sentence.

First, the law states the maximums minimums that a judge has discretion to impose on a miscreant. Their deviations from those sentencing possibilities means that they can be flexible but only if you warrant a break.

Now, to be clear, in traffic court, the judge can consider the facts that got you before him or her and the judge can take human nature into account because some traffic violations are

clearly explainable and were not intended to offend.

Once you have discussed the facts with your legal counsel, it is his or her job to packaged what you have said in terms that indicate that you were either not intentionally violating the was harmless and no one was injured. Turning right on red without a full stop first is a good example.

Judges do not like people being hurt or injured by people who drive in a hapless fashion or do stupid things under the influence of drugs or alcohol or speed through school zones.

One of the fastest ways to incur the ire or wrath of a traffic judge is to: [1] have a long traffic record that shows that you are thumbing your nose at the system or [2] that your attitude is one of, "So what, what is the fuss all about!"

Both are that will have you getting a max fine and sentence because you showing no contriteness or remorse over the infractions.

Judges, supposed to be the conscience of the community and if your conduct violates that conscience with attitude of indifference or being blaise, you are in trouble my friend.

can Judges go Darth Vader real fast when you appear and you have a lengthy record that bespeaks a person who does not want to get their act together. The Judge will

law or that what you did accommodate you with a sentence that shows that his "conscience" has been assaulted by your inexcusable careless behavior.

Now, with the ability of hidden cameras and stealth like patrol cars, your driving habits can be captured for viewing if you try to "lie it out" with the court. Bad move... really bad move!

You would surprised at the alarming number of people who are driving on the streets without either insurance or a valid license and have repeatedly done so before they are caught.

And when they are caught, invariably they may have a rap sheet so long that even the Judge whistles out loud at all of the prior charges which demonstrates this person before him or her is still not complying with the law as to getting and keeping a valid license with insurance.

Some courts are not in the mood to reduce traffic violations of driving while impaired to a lesser sentence because you were a danger to yourself and others by such driving and also upon the belief that you have done it many times before and only now you are being held accountable. Karma will catch you!

lt is something footloose and fancy free about driving a car without insurance and no license. Afterall, it means no responsibilities and you are always thinking that you are too smart to get caught like that other sucker who just got pulled over.

The fees and court costs and fines are deliberately high as serving as a possible deterrent from that person trying that foolish conduct again but, it happens...all the

One can easily catch a traffic offense, or two... but when the courts have a full docket that is full of repeat offenders, mercy goes out the window and the Judge steps up to cool your heels with a heavy fine or a license suspension.

So, a final tip before your traffic sentencing: Minimize any damages by appearing on time, dressing appropriately, minimizing the use of, "Yeah's" and "Naw's"; and take responsibility for your acts and let the Judge know that you have learned a costly lesson and the Judge won't be seeing you again.



## HUD awards more than \$970,000 to LMHA to clean up lead hazards in Toledo

TOLEDO, OH, September 3, 2019 -Department The U.S. of Housing and Urban Development (HUD) today awarded \$970,225 Lucas Metropolitan Housing Authority to identify and reduce lead-based paint hazards in two of its public housing developments. This award is part of the \$27.8 million that HUD issued to

38 Public Housing Agencies (PHAs) in 25 states provided through HUD's Public Housing Capital Fund. These grants will be targeted to approximately 2,800 public housing units, most of which are currently occupied by families with young children (see below).

"We have no higher calling than to make certain the public housing that taxpayers support is healthy for our vulnerable families to live in," said HUD Secretary Ben Carson.

"HUD taking is pro-active measures in families and protecting their children by identifying and addressing housing hazards that have an impact on potential health issues," said HUD Midwest Regional Administrator, Joseph P. Galvan.

"We are very excited and grateful to be awarded this grant and it couldn't have come at a better time," said Demetria Simpson, Lucas Metropolitan Housing Authority president and CEO. "We are working to keep our children and families safe from lead with the Healthy Homes Initiative. We have tested over 500 units in recent months, and now plan to test 1,000 more."

Although lead-based paint was banned for residential use in 1978,


HUD estimates that about 24 million older homes still have significant leadbased paint hazards today. However, homes receiving rental assistance, including public housing, tend to have a lower prevalence of lead-based paint hazards compared to private housing. While most public housing has already undergone abatement, there are still some properties where leadbased paint remains and

hazards have redeveloped.

Lead-contaminated dust is the primary cause lead exposure and can lead to a variety of health problems in young children, including reduced IQ, learning disabilities, developmental delays, reduced height, impaired hearing. At higher levels, lead can damage a child's kidneys and central nervous system and can even be deadly.
