

# Monroe Street Neighborhood Center continues Tuesday free food pantry during COVID-19 Pandemic

Many things have changed at the Monroe Street Neighborhood Center since the onset of the COVID-19 Pandemic. Several popular community programs have been put on hold, people are no longer allowed inside the building and some activities have been canceled, altogether, for the time being.

However, one program has remained strong and steady, and that is the Tuesday Free Food Pantry. Every Tuesday between 11:00 am and 1:00 pm the Monroe Street Neighborhood Center's Food Pantry is open to the public. Unlike some other food pantries in the city, the Monroe Street Neighborhood pantry is open to everyone regardless of where you live. All you have to do is show up and complete a short questionnaire.

Clara Petty, the Executive Director of Monroe Street Neighborhood Center, said, "We were doing this every week, long before the pandemic started. However, since the pandemic began, we are serving more people than we have in the past. Now we are serving anywhere from 50 to 70 families weekly."

She added, "Many people have lost their jobs or are laid off because of the pandemic, and they are not receiving their unemployment yet. In addition, some haven't received their stimulus payment either. Because of these factors and other reasons, the need in the community has increased. We are grateful that we are here and able to provide this service to those in need. We are also grateful to the organizations that help us to provide this service to the public."

Monroe Street Neighborhood Center receives its food from the Northwest Ohio

Food Bank and the Seagate Food Bank, as well as, some items they purchase themselves.

The black fabric shopping bags used

by patrons to carry their food home in are donated to the Center's Food Bank by the non-profit organization CareSource.

The Center aims to provide healthy food to its patrons such as fresh fruits and vegetables, milk, eggs, cereal, pasta, assorted breads from Panera Bread, as well as, other items.

Former Monroe Street Neighborhood Center volunteers and food pantry patron Tammie Crosby said, "Because of the current crises, I'm getting low on things in the house. I came here today to get food to help feed my family. The staff here is really nice and they always treat you real cwell."

Trina Boone a member of Monroe Street United Methodist Church and a former volunteer of the Center also added, "I enjoy coming here and the staff members are very nice people. This is a wonderful and joyful place to be. I also am running a little low on food items so I decided to come here and pick up a food package. These are hard times for a lot of people and this free food pantry is very helpful to the community. We are all in this together and I pray that everybody endures, and stays safe."

# Magic Johnson to Provide \$100M in Capital to Fund PPP Small Business Loans

NBA legend turned social entrepreneur Magic Johnson has committed to providing \$100 million in capital to fund small business loans through the SBA's Paycheck Protection Program (PPP). His companies, Magic Johnson Enterprises and EquiTrust Life Insurance Company, have partnered with a New Jersey-based lender called MBE Capital Partners that specializes in financing minority and womenowned businesses.

In total, Johnson's investment will fund loans for about 5,000 small businesses. He reportedly

"What we're launching here now is so important because we're going to save a lot of small, minority businesses because they can't just walk into the bank and get that loan," Johnson told The Wall Street Journal.

As United's president, Hart will continue to lead the company's public advocacy strategy, including aovernment affairs, corporate communications, legal, and community engagement teams. He also will continue to oversee the corporate real estate, human resources, labor relations, and United's environmental efforts.

"I am honored and energized as I take on these new responsibilities to lead this incredible team that I am convinced will build United into a thriving industry leader," Hart said.

Hart served as United's interim CEO for six months in 2015 while Munoz salaries.


# May 20th Living with Alzheimer's for Caregivers: Middle StageEducational Program Offered Virtually in May

# The Murder of Ahmaud Arbery — and Our Continuing Terror

(TriceEdneyWire.com) - Today there is a national outcry about the murder of Ahmaud Arbery. The public condemnation has forced a belat-

ed response. Those accused of his murder finallyhave been arrested. His murder has become a global embarrassment for whites. For blacks, however, it is another humiliation, a continuing terror. It is the normal silence, however, that condemns thousands of African Americans to unjust deaths and millions to shattered lives. When the camera turns away, the savage injustice that embarrasses us becomes simply business as usual. The horror of Ahmaud Arbery's murder is now well known. The 25-yearold black man went for a jog down the middle of the street in the middle of the day on Feb. 23. Two white men decided he was suspicious, hunted him down and shot him point blank in the middle of the street at 1 p.m.Local law enforcement had video evidence of the crime. Yet no arrest was made until 74 days later, two months and two weeks after the murder. Local authorities chose not to act.

Two U.S. senators said nothing. The white church —that had blessed slavery, segregation, apartheid in South Africa —was silent. Why did the arrests finally take place? Because an intrepid reporter from the New York Times investigated the story and made it public; the murder video was leaked to the public on the 72nd day after Ahmaud's murder. As the public outrage grew, the arrests were made. Never forget, as one commentator noted, they did not make the arrests because THEY saw the incriminating video. They made the arrests because WE saw the video. Embarrassed, faced with an aroused community and an international scandal, they finally acted. So it goes. African Americans suffer in silence the savage injuries of institutionalized racism. We live in northern ghettos —driven there in the early part of the last century by terrorism —most strikingly the

# COVID-19 financial warnings: Consumers and banks should stay away from payday loans

For the foreseeable future, 'normal' life will be indefinitely suspended due to the global pandemic known as the coronavirus.

Record-breaking employment layoffs in the month of March resulted in the Department of Labor reporting that 10.4 million consumers lost their jobs and filed for unemployment compensation. As medical experts continue to track the virus, they havereported at least 2.5 million known infections and at least 90,000+ related deaths.

Beyond these statistics, untold numbers of additional school and retail closures, and an expanding army of people working from home have also been directly affected by the virus.

Consumers both young and old have passed as the virus continues to spread across the country. Its viral wrath has spawned hot spots from the Pacific Northwest's Seattle, to the Gulf Coast's New Orleans, the Midwest's Detroit and the nation's largest urban metropolis, New York City.

Zeroing in on the economic impacts of the crisis, people everywhere are struggling with competing needs in their lives. When living costs exceed available financial resources, tough times lead to tough decisions about how to feed families, keep a home to live in, ways to keep utilities working and a myriad of other day-to-day needs.

Despite a trillion dollar federal rescue enacted with bipartisan support, checks of \$1,200 promised to taxpayers, along with an additional \$500 per child arrived too late for first payments for bills like mortgages and rental payments. Many leaders also warn that despite its size or range of areas addressed, the legislation, was not enough.

In a March 27 House floor statement, Congresswoman Maxine Waters, Chairwoman of the House Financial Services Committee warned colleagues that their job was not yet complete.

"[I] must make clear that the legislation is far from comprehensive, and that there are issues it leaves unaddressed and areas where it falls short...The American people need help now and this bill represents a down payment on that relief," said Waters.

A similar reaction came from AARP chief executive Jo Ann Jenkins.

"Older Americans face the one-two punch of coronavirus's health and economic consequences, and many need immediate relief and ongoing help and support to cope with the pandemic," noted Jenkins. "Those needs are only set to grow

in the weeks and months ahead."

What can really make a difference between life's success and failure is not just what leaders do but also what they didn't do when they had the chance. The recent legislative package was silent on interest rates, as well as forgiveness of federal student loans, negative credit reports or bans on private evictions for late rental payments.

As the cost of living has risen faster and higher than most consumer incomes for more than a decade, the likelihood of a savings account large enough to cover household expenses for a month or more is slim to none.

The Consumer Financial Protection Bureau (CFPB), the agency tasked with protecting consumers from unscrupulous lenders has been conspicuously subdued. Instead of forceful and timely agency alerts via multi-media communications warning consumers about opportunistic scam artists, CFPB has offered a modest tip sheet on how consumers – not government – can protect themselves. Fortunately, as the viral saga unfolds, some news outlets are reporting on the potential harms of consumers turning to payday and car-title loans.

A joint response by five federal regulars - Board of Governors of the Federal Reserve System, Consumer Financial Protection Bureau (CFPB), Federal Deposit Insurance Corporation (FDIC), National Credit Union Administration (NCUA), and the Office of the Comptroller of the Currency (OCC) — came on March 26 in a statement that encouraged banks, savings and loans, and

imbalances, unexpected expenses, or income disruptions during periods of economic stress or disaster recoveries."

Without any specifics defining "reasonable small dollar loans", the regulators' statement could be an inducement to join triple-digit lenders' financial exploitation.

For Black America and other communities of color, predatory short-term loans of \$500 or less began decades ago when payday and car-title storefronts took prominent residence in our neighborhoods across the country. Loans that were marketed as quick fixes for millions of consumers morphed into long-term financial nightmares that deepened debt with every renewal. In many cases, the in-

terest paid on these loans was often double or triple the amount of principal borrowed.

A coalition of civil and consumer rights organizations released a joint statement warning of the possible spike in high-cost lending by the nation's depository institutions – banks, credit unions and savings and loans.

"This is the worst

possible time for banks to make predatory payday loans," said Americans for Financial Reform Education Fund, the Center for Responsible Lending, Leadership Conference for Civil and Human Rights, NAACP, National Consumer Law Center.

"Around the time of the last recession, a handful of banks issued 'deposit advances' that put borrowers in an average of 19 loans a year at over 200% annual interest," continued the leaders. "These bank payday loans disproportionately harmed the financially vulnerable and badly damaged banks' reputations. Since 2013 when regulatory guidance warned against this form of credit, banks have mostly stayed away. We trust that they will continue to do so as they do not want to repeat mistakes of the past."



Ku Klux Klan and their signature lynchings. The Equal Justice Initiative reports there were 4,084 lynchings of blacks in the South from 1877 to 1950. The

Klan, embraced by and often made up of the white gentry of the South, often gathered at their churches to organize the public lynchings. They terrorized blacks to end the fusion multiracial coalitions that grew up in the Reconstruction, and to take back control of their states. The lynchings and violence were greeted with silence, if not approval. White authorities, white churches, white society turned their heads, if they weren't applauding in approval. Fleeing north, Blacks were red lined into ghettos, with jobs hard to get, and discrimination closing doors.

To this day, African-Americans are last hired and first fired. We suffer the worst poverty, the highest unemployment, the highest childhood hunger and malnutrition, the most inadequate health care. This reality is sustained by the silence



of white elites, the silence of the White church, the silence of the evangelicals, the silence of the best minded citizens. Then, the virus hits, and its most lethal

effect is on those who are vulnerable: the elderly, the sick, the hungry, those with asthma and obesity. It hits hardest among the suddenly proclaimed "essential workers" who do the work that previously was largely "invisible: the bus drivers, the grocery clerks, the nurses and medical aides. Not surprisingly, African Americans make up a disproportionate number of those killed or infected by the virus

The racial disparities are so stark that they gain national and international attention. Pundits express shock and outrage at the reports, as if they were surprised by the results. Editorials demand reform. Politicians call for action. The informed public is embarrassed. But little happens: the rescue packages passed by Congress send most of the money to the biggest companies and the most affluent investors. Banks are saved; the post office —with a largely minority workforce —is starved. Hunger spreads. Any expansion of food stamps is blocked. Arrested for leading

nonviolent protests against segregation, Dr. Martin Luther King penned his letter from the Birmingham jail expressing his grave disappointment with the "white moderate" and the "White church." He suggested that the "great stumbling block" for African Americans seeking their freedom is "not the White Citizen's Councilor or the Ku Klux Klanner, but the white moderate "who is more devoted to order than to justice." He decried a religious community "largely adjusted to the status quo, standing as a tail-light behind other community agencies rather than a headlight leading men to higher levels of justice."The virus didn't discriminate. The society enforced the discrimination; the virus just preyed upon its victims. We have gone too long, struggled too hard to adjust to the reality that it is dangerous to be black while jogging or to be black in a pandemic. It isn't enough to express dismay when the newspapers highlight the horrors. We need leaders and citizens of conscience who will act and not restuntil justice is done.

#### What about health insurance?

It's scary to think about getting through this pandemic without health insurance. What benefits you're able to keep all depends on who you work for. The first step is to ask your employer. They may allow you to continue your health coverage for a short period of absence.

If your employer is allowing you to keep your insurance, be sure to clarify if your missed premium payments will be:

- Covered partially or fully by your employer



# Toledo Zoo Debuts Baby Orangutan

Please join Your Toledo Zoo in welcoming into the world and into our hearts a male baby orangutan, Fajar (fah-zhar). Fajar, whose name means dawn or start of a new day, was born on October 12, 2019 to first time parents Leela and Bajik (bahzhee), both Bornean orangutans. At this time, mom and baby remain under the watchful eyes of animal care staff in an offexhibit area with dad nearby as they continue to bond. A public debut date has not been set.

Shortly after giving birth, Leela was observed cradling and cleaning her baby, however,

keepers were concerned about the placenta remaining attached. The decision was made to separate mom and baby for a full veterinary examination. Tests revealed Fajar had an infection in the umbilicus. While being treated for the infection, the new offspring was hand-reared by great apes' staff 24 hours a day. For approximately six months, great apes' staff had to constantly hold the baby, who in the wild would cling to mom, while also trying to maintain a close bond between mom and baby. Keepers trained daily with both Fajar and Leela in hopes of reuniting them as soon as possible. Leela's maternal training behaviors were

# Ohio's update on business reopenings

Last Tuesday, Governor DeWine announced that the Ohio Department of Job and Family Services (OJFS) has received approval from the United States Department of Agriculture for its Pandemic EBT plan. The approval will allow OJFS to distribute SNAP benefits to 850,000 students across Ohio who relied on free or reduced-price meal programs when school was in session to have access to a hot, nutritious meal. The benefits will be mailed directly to students, and families do not need to apply to be eligible.

Families will receive approximately \$300 to purchase healthy and nutritious foods to feed their children. These benefits amount to more than \$250 million that will go to our grocery stores and other eligible retailers.

Sectors licensed by the State Medical Board of Ohio, including massage therapy, acupuncture, and cosmetic therapy, tattoo and body piercing services were permitted to reopen on Friday, May 15 with the implementation of proper safety measures.

The full list of mandatory and recommended best practices can be found on Personal Services Advisory Group .

Ohio Department of Aging Director announced a new service that will provide a daily check-in by phone for Ohioans age 60 or older to ensure that older Ohioans stay connected while staying at home.

The Staying Connected program will call older

adults who sign up for the service during a predetermined window of time. When participants answer the phone, they will be asked to respond via touch-tone to confirm that they are OK or to access live support.

If no one answers after three attempts, a call is then made to an alternate contact (if provided) or to non-emergency services. The service can be canceled at any time.

Eligible Ohioans can sign up at aging.ohio.gov or by calling 1-800-266-4346.

Beginning Sunday, May 31, childcare providers and day camps in Ohio will be permitted to reopen if these providers can meet required safety protocols.

The full list of mandatory and recommended best practices from Governor DeWine's Early Childhood Advisory Council can be found at coronavirus.ohio.gov.

To assist in the reopening of child care centers, Ohio will use more than \$60 million in federal CARES Act fundina provide to reopening grants to all of Ohio's childcare providers, includina family childcare, childcare centers, and both publicly-funded and private providers. More

information on how to apply will be posted to the Ohio Department of Job and Family Services' website soon.

Beginning **Thursday, May 21**, campgrounds in Ohio will be permitted to reopen if these facilities can meet required safety protocols. The full list of mandatory and recommended best practices for both campgrounds and campers can be found at Outdoor Recreation Advisory Group is available at coronavirus.ohio.gov.

Beginning **Tuesday, May 26,** Ohio Bureau of Motor Vehicles (BMV) locations in Ohio will be permitted to reopen for certain services if these facilities can meet required safety protocols. Services that can be accomplished online should still be done online. More details on online BMV services can be found at oplates.com.

Beginning **Tuesday, May 26**, gyms and fitness centers in Ohio will be permitted to reopen if these facilities can meet required safety protocols.

Beginning **Tuesday, May 26,** non-contact and limited contact sports leagues in Ohio will be permitted to operate if these leagues can meet required safety protocols. This applies only to noncontact and limited-contact sports.

A full list of mandatory and recommended best practices from the Governor at: Large Venue Advisory Group.

Beginning **Tuesday, May 26**, public pools and club pools that are regulated by local health departments in Ohio will be permitted to reopen if these facilities can meet required safety protocols.

According to the Centers for Disease Control and Prevention, there is no evidence that the virus that causes COVID-19 can be spread to people through the water in pools, hot tubs, spas, or water play areas. Proper operation and maintenance (including disinfection with chlorine and bromine) of these facilities should inactivate the virus in the water.

This does not apply to water parks or amusement parks. Safety protocols for these venues are in

development.

Beginning **Friday, May 22**, horse racing in Ohio will be permitted if these operations can meet required safety protocols. Spectators will not be permitted.

This does not apply to casinos and racinos. Safety protocols for these venues are in development.

# Everything You Need to Know About the Tuskegee Experiment

Black News - The Tuskegee Experiment, a controversial clinical study carried out between 1932 and 1972, was an experiment conducted on primarily African American men in Macon County, Alabama. These men were being used to study the effects of untreated syphilis, but did not give consent nor were they properly advised of their diagnosis.

The participants were

in fact sick, but while being "cared for" by researchers, many were only given placebos such as aspirin and mineral supplements. Because no effective care was being provided, many of the participants eventually went blind, lost their minds, or experienced other severe health problems due to their untreated syphilis. Others died.

In 1960, Peter Buxton, a U.S. Public Health Service (PHS)

venereal disease investigator in San Francisco, expressed his concerns to his superiors that it was unethical after learning about the Tuskegee study. As a result, PHS officials formed a committee to review the study and later opted to continue

In 1972, Jean Heller of the Associated Press broke the story to mainstream media. This prompted public outrage from Black communities all across the country and forced the study to be discontinued. It led to the 1979 Belmont Report and the creation of the National Human Investigation Board. It also led to the creation of the Institutional Review Board, an independent ethics committee that reviews the methods proposed for research to ensure that they are ethical. A settlement of \$10 million was also awarded to the surviving participants and the heirs of the deceased.

In 1997, President Bill Clinton issued a formal apology from the White House, stating, "The United States government did something that was wrong deeply, profoundly, morally wrong... It is not only in remembering that shameful past that we can make amends and repair our nation, but it is in remembering that past that we can build a better present and a better future."



# Social Security benefits for children with disabilities

SSA's Supplemental Security Income (SSI) program helps children with qualifying disablities and their families. For this program, a child must meet all of the following requirements to be considered disabled and medically eligible:


The child must have a medical condition, or a combination of conditions, that result in "marked and severe functional limitations." This means that the condition(s) must very seriously limit the child's activities.

The child's condition(s) must have been disabling, or be expected to be disabling, for at least 12 months; or the condition(s) must be expected to result in death.

Compassionate Allowances are a way wequickly identify diseases and other medical conditions that, by definition, meet Social Security's standards for disability benefits. Thousands of children receive benefits because they have one of the conditions on the list at www.ssa.gov/compassionateallowances/conditions.htm.

A child must also meet other eligibility requirements. Since we only pay SSI to disabled people with low income and limited resources, a child, who is not blind, must not be working or earning more than \$1,260 a month in 2020. A child who is blind must not be working or earning more than \$2,110. This earnings amount usually changes every year. In addition, if the parents of the child or children have more resources than are allowed, then the child or children will not qualify for SSI. # Princeton University's First Ever Black Valedictorian in 274 Years

In April 2020, Nicholas Johnson, who belongs to the 2020 class of Princeton University, made history after he became the first African American student to ever be named valedictorian in the school's history. According to the University's School of Engineering and Applied Science, he is also the first valedictorian in the department's 21-year history.

Johnson was a dedicated student that majored in operations research and financial engineering. He served as a writing fellow at Princeton's Writing Center, a residential college adviser for Whitman College, and even worked as a software engineer at Google's California headquarters during his senior year. Also his academic interests gave him the opportunity to take cultural immersion trips to Peru, Hong Kong, and the UK.

His senior thesis, "Sequential Stochastic Network Structure Optimization with Applications to Addressing Canada's Obesity Epidemic," focuses on developing high-performance, efficient algorithms to solve a network-based optimization problem that models a community-based preventative health intervention designed to curb the prevalence of obesity in Canada.

"My favorite memories of my time at Princeton are memories of time spent with close friends and classmates engaging in stimulating discussions often late at night — about our beliefs, the cultures and environments in which we were raised, the state of the world, and how we plan on contributing positively to it in our own unique way," Johnson said.

He also announced that he plans to earn a Ph.D. at MIT (Massachusetts Institute of Technology), where he plans to pursue certificates in statistics and machine learning, applied and computational mathematics, and applications of computing.

# FUNdraising Good Times Technology? Digital platforms? Not so fast!

An important aspect of fundraising is "recurring gifts." This refers to individuals who give more than once. Fund development focuses on growing one-time donors into recurring donors. To do this you need access to your fundraising and donor data; you need to use technology as a management tool that informs your fundraising strategy. In other words: you can't skip over fundraising fundamentals as you

focus on how much you are raising through social media sharing. through various methods. Technology and digital platforms are important tools, not a cure all.

We suggest looking at fundraising as focused on relationships, with technology being a supportive tool that assists with fund development and fundraising management. This can include reports (or a dashboard) showing number of gifts, average size of gift, recurring donors, and total raised vs. goal. These reports can inform timelines for appeals, segmenting appeals, and coordinating communication activities reinforce fundraising. Reports can be expanded to include tracking of gift acknowledgment and recognition; they can also inform other forms of fundraising. Digital platforms and online giving facilitate fundraising and extend the reach of your message. They make it easy to give and easy for donors to encourage others to give

In most cases online giving expands awareness of an organization and encourages giving at a low-pain-point. Discussions related to larger gifts may be influenced by a strong and dynamic digital presence, but usually occur through personal conversation and relationship building. Sustainable fundraising requires an eye to both "entry level" giving and engagement of current or potential major donors.

When evaluating how and when you will begin or grow your online fundraising, take a moment to look at the "off-line" basics. You want all fundraising strategies to make a consistent case for giving across all platforms and media. They should reinforce the organization's vision, mission and priorities and be part of a larger process that is built around donor identification, cultivation, solicitation, and retention.

Here are a few more things to

consider: "own" your data and know how to access it. Outsourced campaigns can yield immediate funds; be sure to negotiate ownership of the data that accompanies gifts made to those who fundraise on your behalf. Thank and follow up with all donors. Create engagement strategies, and as appropriate assign donors to "portfolios" for other methods of communication and engagement. Ask new donors for recurring monthly gifts. Document all fundraising methods, contact persons, passwords, processes, and fees; make sure multiple staff know how to access your data and produce reports.

Fundraising success access to technology and use of digital platforms. It also requires knowing how to use data to make fund development and fundraising related management decisions that impact the financial health of your organization. Success requires you have both.


You and your partner are two separate people with your own individual wants and needs which requires you to enjoy

# Shooting Death in Georgia of Ahmaud Arbery is **Defined as a "Modern Day Lynching"**

Months after the U.S. House passed a new lynching law, which has been held up by the Republican led U.S. Senate, and a day after investigative journalist Ida B. Wells was posthumously awarded a Pulitzer Prize — a lynching story dated February 23, 2020 is in the news.

The shooting death of Ahmaud Arbery, 25, went viral on social media on May 6, months after his murder. The video shows Arbery jogging down a street in Brunswick, Georgia. It appears to demonstrate the involvement of three men — two on a pickup truck and another filming the scene from behind.

Arbery's death took place on February 23rd about three miles from where he lived. Arbery was an avid jogger and played football.

The two men on the pickup truck have been identified through numerous media reports as Greg McMichael, a retired investigator in the Brunswick District Attorney's office, and his son Travis McMichael. They appear to follow Arbery from behind as he is jogging down a suburban street. Travis McMichael, the alleged shooter, is seen confronting Arbery and part of a

struggle ensues in and outside of the camera's range. The sound of shotgun fire is heard. Arbery is then seen on video collapsing after the sound of the gunshot in front of the truck.

Brunswick District Attorney Jackie Johnson recused herself because one of the men seen in the video of the fatal shooting pointing a gun at Arbery worked in the district attorney's office.

During an exclusive interview on Roland Martin Unfiltered on May 7th with Arbery's mother, Wanda Cooper-Jones confirmed there was no support of her from anyone in the small Georgia community after her son died. That is changing. Since the viral video has been widely

seen everyone from LeBron James to former Vice President Biden and President Trump has commented on Arbery's death.

"Initially I was told there was a burglary and a struggle over a firearm," Cooper-Jones said on Roland Martin Unfiltered. She confirmed she has not watched the video of her son's death but the description of it from others did not line up with what authorities told her after her son died.

"I need to get these men indicted. They need to go to jail. Two months has



been too long," said Jones on Martin's show answering a question from Dr. Gregg Carr, the Chairman of the African American Studies Department at Howard University.

Late on May 7, Greg and Travis McMichael were finally arrested. Many observers of the breaking news warned that the exotic charges and where any future court case is likely to take place matters.

The Congressional Black Caucus had demanded arrests the day before and released a statement that in part

read, "the killing of Ahmaud Arbery shows us that the spirit of lynching is still alive and well in our nation and something that we cannot tolerate."

"The scary thing for me is the they thought the video would help his client. The culture is so backwards down there they actually thought that," said Arbery family attorney Lee Merritt on Roland Martin Unfiltered. The case has widely been compared to the 2012 murder of Trayvon Martin in Florida by George Zimmerman.

"What happened to #AhmaudArbery is a MODERN DAY LYNCHING. This February, the House overwhelmingly passed the Emmett Till Antilynching Act, which would make lynching a federal crime," wrote Rep. Bobby Rush (D-IL)

South Carolina Republican U.S. Senator Tim Scott wrote, "Every. single.time. The excuses pour in – 'he looked suspicious'... 'we thought he was committing a crime"...The fact remains, #AhmaudArbery was hunted down from a pickup truck and murdered in cold blood. My heart breaks for his family, and justice must be served."

Likely Democratic presidential nominee Joe Biden said, Arbery was "shot down in cold blood," and his killing reflected a "rising pandemic of hate."

"Ahmaud Arbery should still be alive right now. This is tragic and unacceptable. It should ignite us all in demands for justice. I'm calling on the Department of Justice to investigate. We need justice for Ahmaud and his family," wrote Sen. Cory Booker on twitter.

He also represents some of the nation's highest profile civil rights death cases including Alton Sterling who was killed on video by police in Baton

Rouge. Attorney Stewart holds five record jury verdicts in Georgia and is regarded as one of the nation's top injury trial lawyers.

Chris himself is one of the most decorated African-American lawyers in the country having received the 2019 Southern Center For Human Rights Vanguard 2018 Award, Humbles' Civil Rights Award, the National Association's Wiley Branton Award for Leadership, the 2018 Outstanding Citizen Award for the State of Georgia, the 2018 Georgia Senate Outstanding

### **Amendment:**

This is an amendment to the 2015-2020 Five-Year Consolidated Plan for the COT to enable the COT to receive \$4,453,360.00 in Community Development Block Grant (CDBG) and \$2,249,248.00 in Emergency Solutions Grant (ESG) funding from the U.S. Department of Housing and Urban Development (HUD) made available through the Coronavirus Aid, Relief, and Economic Security Act (CARES Act).

Additional CDBG and ESG funding made available to the COT by HUD through the CARES Act is unknown as this time but will be used for the same purpose of the initial allocations indicated above which is to prevent the spread of Coronavirus 19 (COVID-19) and facilitate assistance to eligible agencies, households, and persons economically impacted by COVID-19. In addition, the COT may reprogram recaptured FY 2019-2020 CDBG funding and ESG funding as needed to respond to COVID-19.

Eligible CDBG activities include, but are not limited to, assisting low- and moderate-income households with rental and utility assistance for no more than three months, feeding/meal programs, business assistance to retain employees that are low- and moderate-income, micro-enterprise grants, community center upgrades, and support of other COVID-19 response services. Eligible ESG activities include street outreach, emergency shelter, homelessness prevention, rapid re housing, Homeless Management Information System, and administration.

Further, eligible CDBG and ESG costs incurred as of March 1, 2020, and paid for with nonfederal funds may be repaid with CDBG and ESG funding, including those made under the CARES Act. These pre-award costs will meet all HUD requirements applicable to CDBG and ESG, including those under the CARES Act. Unless waived by HUD, CDBG pre-award costs for FY 2020-2021 will not exceed 25% of the grant and will be used for the CDBG-eligible activities as indicated above.

Public notices regarding future amendments to the Consolidated Plan will be printed in local newspapers and posted online on the COT's website at www.toledo.oh.gov. Specific activities using ESG funding under the CARES Act will not require a 5-day public comment period but will be posted on the COT's website.

Lastly, as part of this amendment, the COT has revised the Consolidated Plan's Citizen Participation Plan to include the 5-day comment period as indicated above as well as to make other changes. The revised Citizen Participation Plan will be available for review on the COT's website at: https://toledo.oh.gov/services/ neighborhood-and-business-development/fiscal-monitoring/reports-information.

As a Transformation Coach I have observed that up to eighty percent of people in any gym at any given time are exercising with improper posture and technique. Bad form and technique over time can lead to low back pain, neck tension and injury. Even worse, bad posture leads to poor results. But did you know that in life bad mental posture can be just as injurious to our well-being?

Many people do not experience success because they are not mentally postured for success. They get out of bed each morning but have already lost the game mentally. Why? Because of a negative consciousness pattern they refuse to change and as a result they move through life defeated, dejected and demoralized. Believers are called to live by a higher standard! In Ephesians 6:10, we are challenged to "be strong in the Lord and in his mighty power."

Principle #1: Feet Forward

Meet Ginger Howard from Darby, Pennsylvania, who made history as a professional golfer when she was still a teenager. In 2010, at the age of 17, she became the youngest African American to turn professional and win her debut tournament. She won 5 events on the SunCoast Mini Ladies Tour, and was the first African American in history to earn a spot in the Junior Ryder Cup.

She actually began playing golf when she was just 6-years old. She says that her dad would take her and her sister to practice with him, and the interest began from there. She went on to train at the IMG Academy with other young top athletes in Bradenton, Florida. During her high school years, she

began taking golf even more seriously and even made it her goal to turn professional one day.

In 2015, she broke through with conditional LPGA Tour status for the first time in her career when she tied for 43rd place in the final stage of the LPGA Tour Qualifying School in Daytona Beach. She also played in the Symetra Tour, the Triple A level of her sport, for five years.

She was also named one of Golf.com's most "Beautiful Women in Golf."

Ginger, who continues to play golf today, says that the strongest part of her game is her mental. Her younger sister, Robbi, who also excelled during her junior golf career but suffered an injury, has become her full-time caddy.

Front-line pay for employees at high risk exposure to CovID-19 due to extensive contact with the public and vehicles such as drivers, mechanics and bus cleaners;

Employee stipends to purchase personal protective equipment. TARTA also provides employees with hand sanitizer, masks and gloves as they are available;

Modified work schedules to minimize

exposure

Social distancing practices for employees and customers; and

Sanitizing and disinfecting all work areas and vehicles.

"Continuation of these policies is just one way to thank our employees' outstanding and vital work during these challenging times," said Dunham. "TARTA will continue to take all measures necessary to protect our employees and customers, while doing our part to reduce the spread of the coronavirus."



same time, Fajar was trained to climb, crawl and take a bottle on a stick through the mesh. While these behaviors are quite advanced for such a voung orangutan. they were necessary to ensure proper care and diet. Throughout the process, much time was spent simply allowing Leela and Faiar to bond. When it was determined that both orangutans were ready, one on one time was introduced. On April 6, 2020, Leela and Fajar were officially re-introduced and when the animal care team saw consistent healthy bonding and proper care, the next step was to leave mom and baby together overnight. Staff continued to observe and when it was determined they were doing well together, human parental assistance was ceased. According to keepers, Leela and Fajar are

continuing to work out a daily routine but continue to bond and grow. Fajar currently weighs just over 12 pounds, has 10 teeth and eats rice cereal mixed with fruits and vegetables, while also starting to sample food from Leela.

"Fajar's story is a true testament to the passion, love and work ethic of our animal care team, specifically the great apes' staff. They stepped in and cared for this new baby just like parents. They worked around the clock, stuck to feeding schedule. changed diapers and even wore him in a baby sling while they worked to ensure proper strength and form for him to hold on just like in the wild. Successfully reuniting mom and baby was always the goal and we could not be prouder of our team and the new orangutan family," said Suzanne Husband, associate curator of mammals.

# Black People Invented Memorial Day, But That Part Got Erased From History (Well, Almost!)



U.S. Colored Troops from the Civil War. Memorial Day, formally known as Decoration Day, was originally started by a group of African Americans. Yes, The History Channel and many other credible historians have confirmed that the popular holiday was, in fact, initially an event held by newly liberated Blacks in Charleston, South Carolina.

It happened on May 1, 1865 right after the Civil War ended, when thousands of newly freed slaves and regiments of the U.S. Colored Troops gathered to march around a Confederate Army prison camp in honor of the unnamed fallen Union soldiers who

fought for their freedom.

Also in attendance were thousands of Black women and children who reportedly sang hymns and carried flowers, wreaths, and crosses.

And then the holiday got whitewashed

Historian and author, David W. Blight, said in his Historian and author, David W. Blight

book Race and Reunion: The Civil War in American Memory that years later African Americans were suddenly erased from the story by white Democrats after regaining control of state politics at the end of Reconstruction.

Yes, that's right. A day that originally celebrated Black liberation was now being utilized for white supremacy, and it apparently all started from an 1865 article that was published in the Charleston Daily Courier that tried to discredit the facts.

After discovering that news article, many historians have agreed that after being freed, one of the first things this group of African Americans did was gather to pay tribute to those who died while fighting for freedom. Sadly, you usually don't hear that part of the story.

According to LiberationSchool.org, "the spirit of the first Decoration Day - the struggle for Black liberation and the fight against racism - has unfortunately been whitewashed from the modern Memorial Day."



