Local Covid-19 Survivor Jenai Hicklin has message for brown and black people

Jenai Hicklin has a message for brown and black people. As a local minister who prepares meals for the homeless, leads Bible study, and cares for those in need, Ms. Hicklin's voice is already heard and heeded by those in the community who know that she lives what she preaches. Now, as a "miracle" survivor of Covid-19, the disease caused by the novel coronavirus, she hopes more people will listen and heed her warning about the seriousness of the virus that has caused a worldwide pandemic.

In late March, Ms. Hicklin who suffers from asthma initially thought that she was experiencing an asthmatic flare up.

"I have asthma, and I had a cough that didn't feel right. I went to the doctor, and she asked me all the Covid questions. She said if you don't sound any better in two days, call me. Well, I called the office because I still had that funny little cough that I thought was my asthma. [My doctor] said I don't like the way that you sound. Go to the ER, and I'll meet you there," Ms. Hicklin recalled.

Ms. Hicklin said she did not have a fever, one of the primary

symptoms of Covid-19, until she walked into the ER. With a temperature of 103 degrees, she was rushed to the back. Once there, she said the first ER doctor to examine her said, "I don't hear anything."

"I said what do mean you don't hear anything. How am I breathing if you don't hear anything? He went and got the nurse practitioner. She came

in and listened. They both walked out and literally a team of people, probably about 3 or 4, came in with the masks on and all the garb," Ms. Hicklin recalled. "I had three IVs in me in about 10 minutes, and I'm still not knowing what's going on because they were just moving and doing."

Ms. Hicklin said she eventually looked up and saw her primary care physician Dr. Coral Matus standing outside the room. She said Dr. Matus reassured her that everything was going to be okay and that the team was going to administer some medicine. Ms. Hicklin then asked to call her son John.

"I called my son and told him baby I'm at the ER, but they said everything's going to be fine. I got this cough and

she had contracted the coronavirus that causes the disease Covid-19.

Ms. Hicklin said her son John was not immediately notified of her condition until day 2 or 3 of her coma. After calling the hospital repeatedly, he was finally informed of his mother's condition.

"They told him your mom has contracted the virus, but the problem is she has pneumonia in one lung, the Covid virus in the other lung, and it has caused her asthma to flare up really bad," Ms. Hicklin said. "So, my body was fighting three things at one time."

Ms. Hicklin recalled that the doctors told her that while in the coma, her lungs had collapsed at one point, and she almost "died on the table twice." Her son was also informed his mother's condition was not "looking good."

It wasn't until day 12 of her coma that her son John was given "good news." Six days later, Ms. Hicklin said she was off the ventilator and awake. And within two days of coming off the ventilator, she was breathing on her own without oxygen.

"It's definitely a miracle, and that's what the nurses kept saying when they were coming in," Ms. Hicklin said. "Some of the nurses that were with me on the vent were also with me during the step down. They would come in the room and just look at me and say Ms. Hicklin you just don't know. You are a miracle. We did not think you were going to make it."

On April 16, Ms. Hicklin left the hospital but is still recovering and under quarantine. She said that she has had to re-learn to walk, use

the doctor said they're going to give me some medicine and probably a breathing treatment, and I'll be okay," Ms. Hicklin said.

That was March 25 and the last thing Ms. Hicklin remembers until she emerged from a medically-induced coma 18 days later. It was then she was informed that

utensils, and will eventually go through intensive physical therapy. After her experience, Ms. Hicklin said it pains her to see brown and black people not taking the virus as seriously as they should.

More than 70,000 people with the coronavirus have

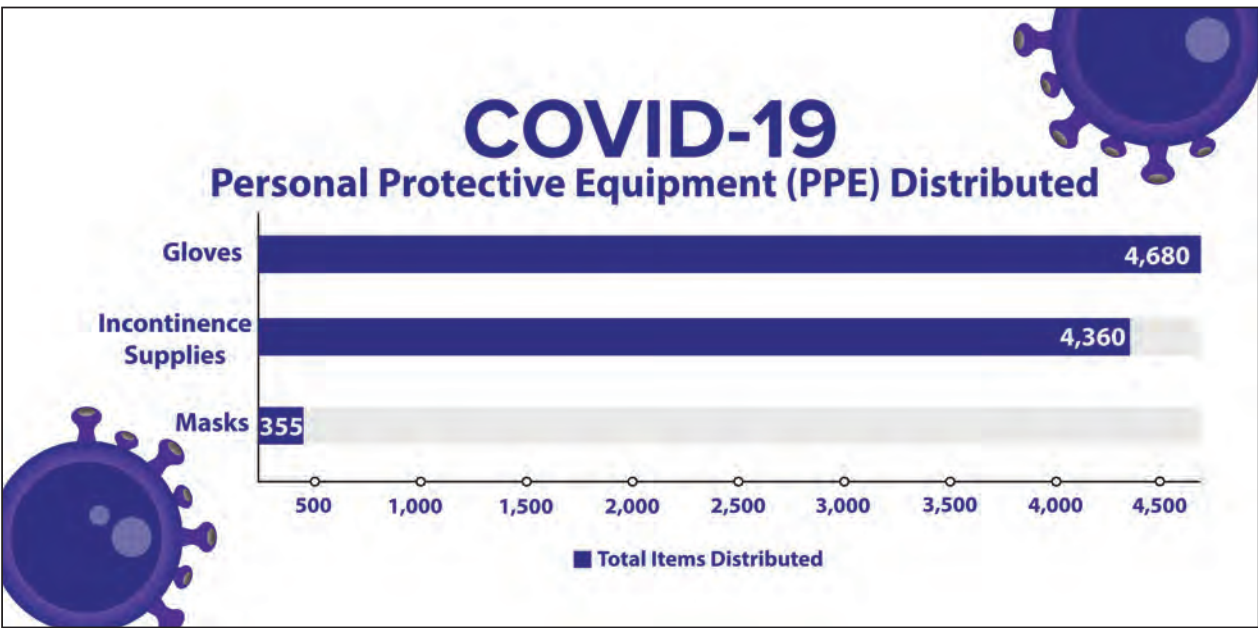

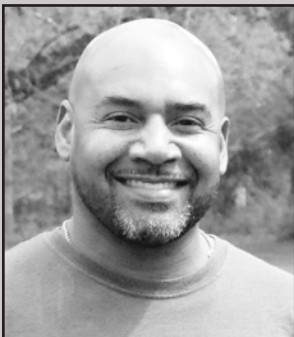

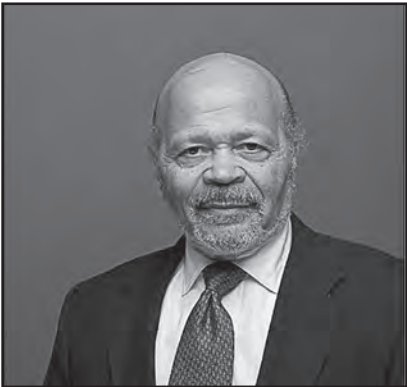

The Long No

An acquaintance in the entertainment industry once explained to me why a project we were working on was stalled. He said we were getting “The Long No.”

He explained that in Hollywood, when someone does not like a project presented to him but does not want to offend the

presenter because he may want something from that person in the future, he will drag out the rejection to soften the blow.

Having spent my formative years in a rural community, I was able to equate this tactic to what we called “frogs in a boiling pot.” As kids, we had heard that you could put a frog in a pot of cool water and set the pot on a low burning flame. And if you heated the water slowly enough, the frog would sit in a pot of boiling water until its death.

I never tried this frog experiment, but living in America, I have witnessed the same thing occur with African Americans in this country

Centuries of attacks and abuses suffered by people of color have rendered many of us unaware of the ever-increas-

ing dangers we face. Like the walking dead, we each wander through a life void of many of its meaningful qualities. We stand for renditions of The Star-Spangled Banner, giving no thought to the fact that it was written by a white supremacist and contained verses pledging death to people of color fighting for their freedom

We shipped off to foreign lands to fight and die for the rights of people abroad, but did not have those rights at home. We join municipal police forces only to be gunned down by fellow officers responding to the color of our skin

As appalling as these facts are, because they have constantly occurred over many decades, people of color have become numb to all but the worst abuses.

Affirmative Action Remains MIA in Trump Administration – Where is the Outcry?

There seems to be a very strange quiet regarding all organizations that claim to be defenders of Civil Rights and protectors of our hard-fought liberties won through the results of institutions that fought against segregation, lynchings and bloody demonstrations. Dr. Martin Luther King, Medgar Evers and others are “rolling in their graves” as the current White House has just disassembled the hard-fought victories of the 1990’s.

Reacting to the dismal state of our economy and the pandemic of the Coronavirus, the White House sponsored the infamous CARES Act. This new program relieves all federal agencies of any responsibilities regarding the Civil Rights Act or Affirmative Action. Basically, all departments can set aside any enforcement of Title VI of the Civil Rights Act of 1965. Minorities such as Blacks, Hispanics, females and virtually all entities that are not white males can no longer feel protected.

Also, and worst, historical groups that are known as protectors of basic civil rights are not uttering a word. Where is the NAACP? Urban League? National Action Network etc. during this controversy? Potential contracts and financial agreements are being snatched away by the billions of dollars. “This is going to set back Black families by

generations”, says Harry C. Alford, President and Co-Founder of the National Black Chamber of Commerce. “We are beginning the fight and it is rather lonely. The momentum must build as we go.”

Last week, the Chamber led a 2,000 participant “Call to Action”. “We are getting a constant flow of new members joining us in this fight”, Alford states. “We are in disbelief and we better snap out of it as soon as possible.”

As written, the Affirmative Action law is suspended for ninety days and authorizes ninety-day extinctions thereafter. This

means the drought can last for years before being permanently cancelled.

We must begin to fight with all our hearts if we do not want this tragedy to turn into a most terrible nightmare for our children and thereafter.

Raise your hand if you have heard of Arthur Fletcher. He was known as the “father of Affirmative Action”.

According to the Seattle Times, after Richard Nixon’s election, he appointed Fletcher Assistant Secretary of Labor for Employment Standards. With responsibility for the wage and

hour regulations for the nation’s workforce and supervision of the Office of Federal Contract Compliance, Fletcher now had the power to revoke federal contracts and keep contractors from bidding on future work.

On June 27, 1969, Fletcher implemented the nation’s first federal affirmative-action program, which required federal contractors to meet specified goals in minority hiring for skilled jobs in the notoriously segregated construction industry.

But after two years, Fletcher’s affirmative-action programs had earned him so much enmity among the leaders of the skilled construction unions that he was forced to resign.

President Nixon gave him a brief assignment on the United Nations delegation under Ambassador George H.W. Bush that created a lifelong friendship.

Arthur Fletcher, our mentor, travelled the world with us to Brazil, Cuba, and countries in Africa as we sought contracts for our members. He once told us the story of him being held against

his will inside the Palmer House Hotel in downtown Chicago by construction union goons. He felt his life was in danger and frantically called the White House.

As the story goes, President Richard Nixon made an immediate direct phone call to Chicago Mayor Richard Daley and shouted: “If my man is harmed you are going to wake up to the marching of the 101st Airborne down Michigan Avenue.” The bigots backed off.

Gone are those days of courageous leadership. We just wish they would return. Oh, how nice it would be for our nouveau leaders to stand up in a courageous manner such as Louis Sullivan, Art and of course Dr. Martin Luther King, Jr.

We have a lot to lose if we do not wake up and protect the things we have fought so dearly to win.

But the COVID-19 virus has narrowed the focus of the epic journey of African Americans in this country. This coronavirus has enveloped the entire globe, with the consequences spotlighting the iniquities created by the expansion of Western culture into the rest of the world.

Under this spotlight, one term that has come to the fore is “comorbidities” as it relates to the chronic health problems suffered by people of color because of oppression at the hands of white supremacy.

It is unnecessary to recount the centuries of exploitation of people of color through slavery and colonialism to lay the factual foundation of these inequities. The centuries-old abuses of people of color are well documented. As one health professional put it: We are “seeing differences in the impact on blacks with respect to the

new coronavirus” because of “consistent, systemic, structural, continuous racism that permeates every aspect of what we refer to as civilized, first-world, privileged, American living — including health and health care.”

The National Center for Biotechnology Information at the U.S. National Library of Medicine has published a report stating that the “relationship between race and comorbidity is of potential clinical and public health importance. The prevalence of comorbidities varies by race in the United States, with Blacks having higher rates and earlier onset of comorbid conditions than Whites.”

Systemic, societal problems, not simply an individual’s behavior, are now seen as the causes of certain comorbidities disproportionately suffered by people of color, and there needs to be a push for interventions to “backstop the biological fallout of

living with oppression.”

While we push to end these systemic and social causes of disproportionate comorbidities, we must also address the problem of disparate health care delivery. Even the American Bar Association has ac-

knowledge that “some people in the United States were more likely to die from cancer, heart disease, and diabetes simply because of their race or ethnicity, not just because they lack access to health care.” This acknowledgement cited a report from the National Academy of Medicine that stated, “racial and ethnic minorities receive lower-quality health care than white people—even when insurance status, income, age, and severity of conditions are comparable.”

For centuries, bit by bit, people of color have been told “No!” to the enjoyment of the blessings of liberty. What happens next depends on us. We can continue to be complacent like the frogs in the boiling pot and take no notice of the fact that the social structure of America is killing us, or we can grab the levers of social power through voting and civic activism to save ourselves and the generations of people of color to come after us.

City of Toledo Neighborhoods Department employees distributed nearly 30,000 disposal masks and nearly 6,000 pairs of gloves on May 1, 2020 to churches, neighborhood organizations, local agencies, and other groups, which will dispense the supplies to the public, and in some cases to staff members working with the public, to help fight the spread of COVID-19.

"The cost of the masks and gloves will be reimbursed to the city with Community Development Block Grant Funding," said Monica L. Smith,

Neighborhood Navigator for the City of Toledo.

"There is an urgent need for masks and gloves in our community, and for the organizations that have requested assistance," Ms. Smith said. "We will be safely distributing these supplies so they can be used to help flatten the curve and fight the spread of COVID-19."

Toledo Mayor Wade Kapszukiewicz thanked all of the organizations working with the city to help fight COVID-19. "Efforts like this are critically important in this fight," he said. "We are in this together and I am proud to see

On April 28, 2020, face coverings were required of the public, court employees, and all other individuals who enter or remain in the building. Entry will be denied without a face covering.

Beginning May 18, 2020, the Court will begin to phase in regular court operations according to the following schedule below. Face coverings are required of the public, court employees, and other individuals seeking to enter the building.

May 4-15, 2020

Continue as ordered under 20-COVID-008 with hearings limited to in-custody defendants only by video from the jail; and limited out of custody cases as petitioned by parties and ordered by the Court. Face coverings are required to enter the building.

May 18, 2020

Courthouse will open to include scheduled CRA (Felony) CRB (Criminal) and TRC (Operating Under the Influence) cases. This includes pretrials and trials on individual judge dockets and the 9:00 out of custody arraignment docket for CRA, CRB and TRC only. Face coverings are required to enter the building.

Duties will open to warrants only (open and bench warrants). Any other Duties matters must be addressed by filing a motion with the Court. Other than warrants, access to the Courthouse is strictly limited to persons (attorney, defendant, victim, witness) with scheduled cases.

The Judges mandatory docket rotation will return to normal.

Courtroom 3 will continue to hear all (misdemeanor and felony) in custody cases by video from the jail until otherwise ordered. Courtroom 3 will hear all felonies (in-custody and out-of-custody). Courtroom 4 will hear all out of custody misdemeanor CRB and TRC arraignments. This procedure will continue until further notice. Duties is limited to warrants only.

Start times for scheduled assigned cases on individual Judges dockets will be staggered: Cases with private attorneys will be scheduled for 9:00am; cases with public defenders will be scheduled for 10:00am; and Pro Se cases will be scheduled for 11:00am.

Ohio Housing Finance Agency Provides Additional \$5 million for Emergency Homelessness Services

In a special meeting on Thursday, April 23, the OHFA Board approved an additional \$4.75 million to support the increased housing needs of Ohio's homeless and those at risk of homelessness due to the COVID-19 pandemic. The Board also approved \$5 million in emergency funding in March.

The monies will go to Ohio's nine Continua of Care and the Coalition on Homelessness and Housing in Ohio. In addition, an additional fund will provide financial help to nonprofit organizations with properties previously funded by OHFA that operate senior housing, permanent supportive housing and affordable assisted living properties.

The Board approved the following:

- \$2.5 million in Emergency Housing Assistance Funds to the nine CoCs
- A \$750,000 grant to COHHIO for its Pandemic Emergency Fund
- A \$1.25 million no-interest loan to COHHIO for TANF Advance Funds
- A \$250,000 COVID-19 emergency fund

rapid re-housing efforts. The organization will disburse the \$1.25 million and repay OHFA through a TANF reimbursement.

The final allotment addresses a need for Ohio's most vulnerable citizens and the organizations that serve them. Owners and management companies of OHFA-financed properties can apply for grants to purchase protective equipment, cleaning supplies and more. Nonprofit organizations that create emergency housing funds to address emergency needs related to COVID-19 at affordable housing properties and facilities across the state may request a contribution to those funds.

OHFA will disburse Emergency Assistance Funds based on a formula corresponding to the number of extremely low-income and very low-income residents in CoC service areas. Details about the second round of Emergency Housing Assistance will be posted on OHFA's website on Monday, April 27; funds will be disbursed by May 31.

"As the coronavirus has continued to spread, the housing and safety needs of those who serve the homeless and persons at-risk of homelessness have also continued to grow," said OHFA Executive Director Sean Thomas. "We are grateful to our Board's leadership and are proud to offer our support to the number of organizations in the state serving these vulnerable populations."

Ohio CoCs will continue to provide rapid re-housing and homelessness prevention efforts with the additional funding. However, today's approval provides additional flexibility for the CoCs to use the funds to isolate and quarantine facilities or provide hotel/motel assistance for homeless Ohioans.

OHFA's contribution to COHHIO's Pandemic Emergency Fund enables the organization to continue helping homeless shelters throughout Ohio contain the spread of COVID-19 among residents, staff, and the broader community.

"We've received hundreds of donations, but the needs are enormous, and we nearly exhausted the Emergency Fund. OHFA's generous contribution enables us to continue supporting shelters, and it will certainly save lives by keeping vulnerable Ohioans – seniors, people with health conditions, and families with young children – out of harm's way," said Bill Faith, COHHIO's Executive Director.

The loan will support COHHIO's efforts as they await Temporary Assistance for Needy Families dollars that Governor Mike DeWine approved for homelessness prevention and

June 1, 2020

Courthouse will open to hearings on civil cases and Small Claims. The courthouse will also open to payment of fines, costs, and fees and court filings. Battling Covid-19, hunger at the 'Doug'

Saturday morning, May 2, at the Frederick Douglass Community Center, 1001 Indiana Ave., wasn't the typical Saturday. Cars began lining up in the parking lot, hours before the 10 a.m. start to a free giveaway of face masks/coverings, disposable gloves, and food. That line of cars would extend out the parking lot, onto the street of Indiana, and extending west to Detroit Ave.

In conjunction with Promedica, and the Lucas County Health Department, the Frederick Douglass Community Center, simply known as the "Doug," gave away 400 masks, and enough food to feed 200 families, according to Albert Earl, president of the board. "The 43607 zip code is being hit the hardest, and so it only makes sense for us to do what we can to help," he said.

Dina Ramirez, a health educator for the SOR Program was passing out literature on drug usage, and how to seek help. Additionally, she was distributing free cans of Narcan, which is administered to drug users when they overdose on heroin. "Since the outbreak of Covid-19, we've seen a spike in heroin use, particularly in the 43612, and 43609 zip codes," she said. Shirley Porter was the first car in line to receive her free masks, and food. She wore a face covering while waiting. "I love me some Shirley, that's why I have this over my face," she said. "I'll do anything to protect my life. As far as those people who don't wear masks, you have to know this virus doesn't

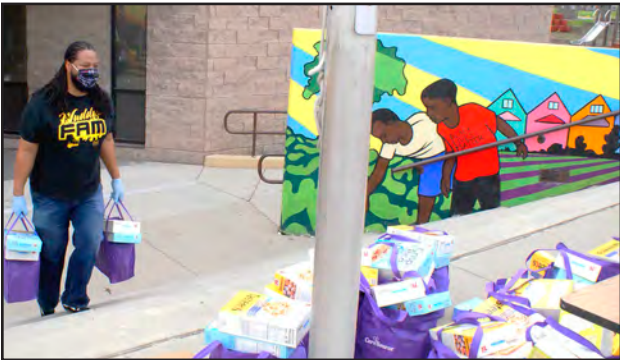
discriminate. You keep going without a mask, and you may come up with the virus; I tell my son the same thing, because he doesn't wear a mask," Ms. Porter said. "I know I'm kind of far back, but it's worth the wait," said Deborah Rockett. "I'm retired, and have to miss out of a food giveaway, nor distribution of masks to protect me from Covid-19. I know two people, locally, who have died from the virus and others outside of Toledo; so this is a very serious matter to me," she said.

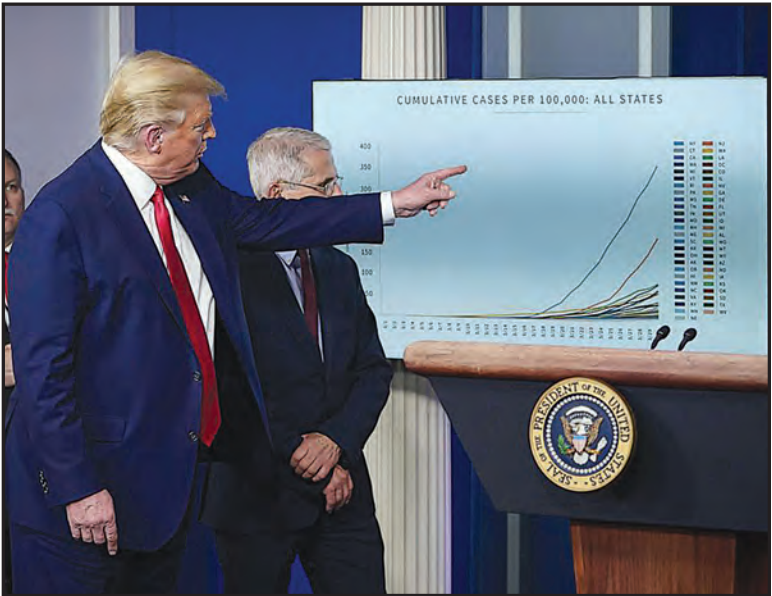
Is 45 this ignorant, or is he merely deflecting from the many mistakes he has made, as our nation's leader, in combatting

Not to mention his enthusiastic embrace of hydroxychloroquine, touting it in several press briefings as a "game-changer." The Food and Drug Administration (FDA) has cautioned against the use of the drug except in a hospital setting or clinical trial. Did 45 ask for their advice? 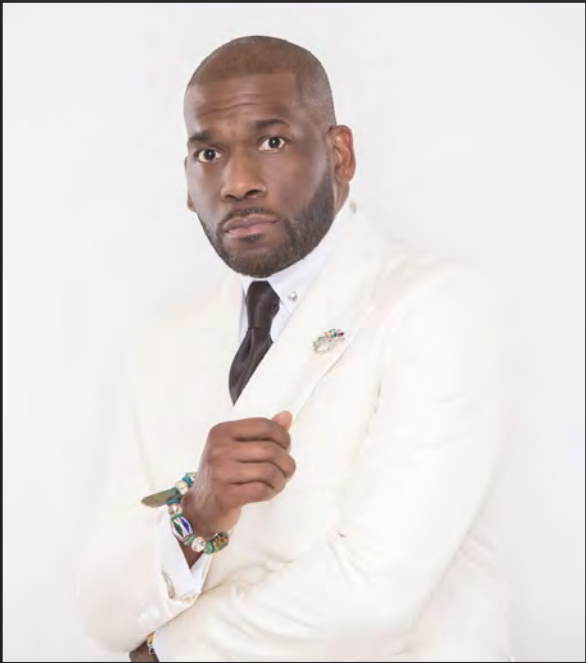

I recently came across an article on NewsOne.com that highlighted a furor on several social media platforms regarding whether wealthy pastors are contributing enough to COVID-19 relief efforts.

Admittedly, some of the social media memes and tropes were amusing and of course, some were outright meanspirited, sophomoric and disrespectful but that's the complex mosaic of the social media space and if you're the public square at all, you have to be able to stomach the bitter and the sweet.

As I processed the article and the dialogue it generated, my personal and pastoral PTSD was kicked into overdrive recalling the pummeling my church (New Birth) and I took just a few weeks earlier when we announced that we'd formulated a partnership with a telemedicine firm and a community health clinic to provide coronavirus testing to our community.

Without bothering to do any due diligence, we were labeled as "opportunists," "vultures," "ungodly" and worse.

And while it is always painful to be insulted and castigated, it hurts even more when it's the African American community leading the campaign of misinformation. Of course, New Birth and I were confident in our intent and execution of the testing initiative and fortunately, local affiliate C BS 46, cleared the issue up nicely and we're moving forward.

Rather than get lost in trying to salve healing wounds, I believe our focus should turn to the larger question of what exactly the role of the church should be, not only in this season of a global pandemic but as the core societal anchor of the African American community.

I've preached many times that 93 percent of what Jesus did was outside of the walls of the church as he healed, fed, evangelized and organized.

Admittedly, if you were to honestly assess the 21st century church, that dynamic has been completely flipped. Far too many churches and pastors are concerned with what happens inside of the building and not concerned or active enough with affecting the greater community, and those who need to be ministered to beyond the opulence and comfort of gleaming wood floors and the immaculate stained glass.

We indeed have a conundrum. Should the church be doing more? Yes; and if you look closely many churches are doing plenty.

I am blessed to pastor at New Birth, where we have the capacity and more importantly, an engaged, committed church family who take seriously our mandate to love, lead and live like Christ. Our goal is to be a church that does 93 percent or more of our ministry beyond the walls of our beautiful sanctuary.

In a little over a year, we have provided meals for furloughed federal workers; we have provided 5 000 pairs of free shoes for school-aged kids in the DeKalb/ Atlanta community; we have b ailed o ut first time, nonviolent offenders; and married 30 couples free of charge in two mass w eddings.

Even as we are all in the chaos and calamity of the COVID-19 pandemic, we have decided that even if church has stopped, ministry doesn't.

Consequently, we are providing free groceries to 1000 families each week and we have entered a partnership with local hotels to provide free lodging and meals to our beleaguered doctors, nurses and allied health professionals.

This is the work of the church and it is not only having a major impact in the community; it is helping to attract souls to Christ and members to our church. To God be the glory for over 300 new members who have joined New Birth since

Our goal is to be a church that does 93 percent or more of our ministry beyond the walls of our beautiful sanctuary. In a little over a year, we have provided meals for furloughed federal workers; we have provided 5 000 pairs of free shoes for school-aged kids in the DeKalb/ Atlanta community; we have bailed o ut first time, nonviolent offenders; and married 30 couples free of charge in two mass w eddings. Even as we are all in the chaos and calamity of the COVID-19 pandemic, we have decided that even if church has stopped, ministry doesn’t. Consequently, we are providing free groceries to 1000 families each

Remembering Dr. Dorothy Irene Height

April 20, 2020 marks the 10th anniversary of the death of our gentle but fearless leader and mentor, Dr. Dorothy Irene Height. This significant anniversary offers us an opportunity for reflection during these unprecedented times we are living in today. Dr. Height undoubtedly was a creative, compassionate, and visionary leader. Her scholarship, travels and experiences shaped her understanding of power and how to navigate it with competence and kindness. Through the programs and initiatives she developed, she used her power to empower poor women and girls around the world. During the early Civil Rights Movement when women worked behind the scenes, her quiet power brought wisdom and a social worker’s perspective to deliberations and strategies of the “Big Six” civil rights leaders. With an understanding of the importance of power of location, she purchased a building in Washington, D.C. between the White House and the Capitol, the only African American-owned building along that corridor of power. For decades, her political power was put to use serving as an advisor to five U.S. presidents. She led some of the largest and most influential women’s organizations

in American history, including her beloved National Council of Negro Women. And she achieved these accomplishments always wearing fabulous hats and an engaging smile. While those achievements were immense, they pale in light of her greatest and most enduring accomplishments. During the turbulent times and critical issues that prevailed throughout her lifetime, Dr. Dorothy Irene Height was “A Bridge Over Troubled Waters.” Her activism started as a teenager by bringing her peers together to nonviolently protest policies that prohibited African American children from swimming, debating or going to school with Caucasian youth. Through programs she implemented, she was at the forefront of the Y.W.C.A. realizing its most significant lifelong mission, eradicating racism. None of these were simple or easy undertakings, yet she courageously pursued

what she knew to be right and good. Wherever the waters were troubled, she created a bridge, effective coalitions, and solutions. Many of the critical issues of Dr. Height’s era persist today. Over fifty years ago, she called attention to the health disparities related to social detriments, especially for Black women and the elderly. Chronic health conditions such as hypertension, heart disease and diabetes were always at the forefront for education and outreach to our communities. Today with thousands impacted by COVID-19 and millions who are unemployed, the consequences of these same health disparities are more apparent than ever. The troubled waters we now face have washed waves of reminders of the work our country still has to do. Leaders are searching for answers, managing fears and anxiety, and competing for vital resources in their communities. In these turbulent, frightening, and uncertain times, we are called to embrace Dr. Height’s spirit of direct action, by courageously bridging the waters with viable solutions, to serve the needs of our brothers and sisters, to hold leaders accountable for environmental and social justice policies, to provide food for the many who are in need today, to protect and defend the right to vote, to be the voice of the voiceless, and to lead with purpose and passion toward a just and safe society.

we suspended our in-person worship a month ago. I am proud of what we are doing at New Birth but there are plenty of other churches who have stepped up in a major way even if they are less heralded, barely noticed and never celebrated. It is disheartening to see so much misinformation gain momentum and to see the church chastised and rebuked in haste and seemingly at will. The church is needed now more than ever

and as we emerge from this recent Easter holiday, I am praying for my comrades of the gospel and I am hopeful that we as a people will be less antagonistic towards the body of Christ and that God will resurrect our hopes, restore our compassion and revive our love and interdependency on one another. These times are challenging, stressful and unprecedented; it calls for all of us to raise our game and our consciousness in the hopes that we will emerge as a stronger, better connected community.

should not be used internally, "Under no circumstances should our disinfectant products be administered into the human body through injection, ingestion, or any other route," a Lysol spokesperson told NBC News. A day later, he attempted to explain his remarks, but he outright lied about what he said.

Is 45 this ignorant, or is he merely deflecting from the many mistakes he has made, as our nation's leader, in combatting the deadly and highly infectious virus? From urging people to go to church on Easter Sunday (he took it back), to telling states they can open for business before testing results are back, he has taken the nation's health into his hands and imperiled our collective health as a result. Not to mention his enthusiastic embrace of hydroxychloroquine, touting it in several press briefings as a "game-changer." The Food and Drug Administration (FDA) has cautioned against the use of the drug except in a hospital setting or clinical trial. Did 45 ask for their advice? Or did he go to med school when none of us were looking?

During the daily briefings, I've been extremely impressed by Dr. Anthony Fauci, the blunt-talking director of the National Institute of Allergy and Infectious Diseases. While he is not disagreeable, he is not afraid to openly disagree with 45. He's been leading NAIAD since 1984 and was instrumental in working on ways to contain the HIV/AIDS epidemic. The President seems so tone-deaf to Dr. Fauci's advice and the advice of Dr. Deborah Birx, the White House Coronavirus Response Coordinator. Previously, she served as the United States Global Coronavirus Response Coordinator. Watching her body language when 45 speaks suggests that she does not have to contradict him verbally to make her displeasure. When he ignores the advice of these medical experts, he endangers our health. According to the President, there has been sufficient testing. Most experts disagree.

He says that anyone who wants a test can get one. That's a bald-faced lie. Indeed Larry Hogan, the governor of Maryland, had to get 500,000 tests from South Korea because the federal government either didn't have them or would not distribute them.

Mr. Trump has missed no opportunity to praise himself for doing "a great job" in combatting the coronavirus. He has missed no opportunity to demean or condescend to the media. He has turned a severe world pandemic into a chance to bloviate, lie, and offer self-congratulations. I laugh to keep from screaming, even though since I'm sheltering in place, no one would hear me. While there is nothing funny about a virus that has, in just a couple of months, killed more than 50,000 people, some of the Trump remarks are amusing, amazing, and, ultimately, disgusting.

The White House attitude toward the states also endangers our health. Disaster relief funds include money for hospitals. It also has money available for the states. But through a murky set of rules, the states cannot use the funds for state operations, only for COVID-19 related expenses. How do we tell the difference, especially when state operations (including health operations) are strained by the virus? Senate Majority Leader Mitch McConnell says the states can go bankrupt. These attitudes are hazardous to our health.

The President is not concerned with our physical health, but with his political health. That is why he has sparred with governors, the press, and others. That's why he has been opposed to mail ballots, even as he casts them himself. That's why he has approached a dire situation with bluster and braggadocio. That's why he has failed to wear a mask, failing to model the kind of behavior all of us, including his acolytes, should emulate.

Scientists are looking for a vaccination against the coronavirus. Our nation needs protection against our President.

CDC's Prescription: Individual Housing for People Experiencing Homelessness During COVID-19 and Beyond

Washington, DC –The Centers for Disease Control and Prevention (CDC) updated their official guidance on COVID-19 to include sheltered homeless populations, stating, "Depending on resources and staff availability, non-group housing options (such as hotels/motels) that have individual rooms should be considered for the overflow, quarantine, and protective housing sites." The CDC's guidance for unsheltered populations already emphasizes that "Unless individual housing units are available, do not clear encampments during community spread of COVID-19." The National Law Center on Homelessness & Poverty (the Law Center) is grateful for the CDC's guidance, and hopes governments will use it as a baseline to build upon.

This new guidance comes as new stories of widespread asymptomatic spread at congregate homeless shelters in San Francisco,

Boston, Dallas, Los Angeles and other cities are emerging. The Law Center has pushed the effort to house people experiencing homelessness in hotels, motels, and/or RVs for the duration of the crisis, and to make sure they never have to return to the streets after the crisis is over.

"We call on hotel owners—and especially those who have been helped with our public dollars through the federal relief package—to act in the public good and make it easy for communities to follow the CDC guidance to quickly place people experiencing homelessness into their vacant rooms for the duration of the pandemic," stated Maria Foscarnis, Executive Director at the Law Center. "We also urge elected officials to use vacant federal, state, and local properties for emergency housing and as a space to help transition people experiencing homelessness into permanent housing after COVID-19."

The CDC also emphasizes that communities

should "plan for how to connect clients to housing opportunities after they have completed their stay in these temporary sites." Elevating conversations on housing services post-COVID-19 allows us to step back and think about the long-term solutions we need to end homelessness.

"Given what we now know about the aerosolization of COVID-19 and asymptomatic spread, it is inexcusable for communities not to be moving people into individual housing units as quickly as safely possible," said Eric Tars, legal director at the Law Center. "And to prevent the next wave of COVID-19, we need to make sure we are building the capacity so that once people are off the streets or out of shelters, there are permanent places for them to stay, and no one ever returns to the streets. Housing is healthcare, and both are human rights that need to be guaranteed to all, for all of our good."

But it’s not just Cardi B or “GMA” who’ve taken notice of Kennedy’s “financial movement”—so has Kaavia Union Wade who has more than 1.1 million followers on Instagram. She is the daughter of NBA Legend Dwyane Wade and his wife, actress Gabrielle Union.

“I love dancing to ‘Piggy Bank’ Keep it up!” she wrote on a recent Instagram post.

“I am grateful and really appreciate the exposure that Cardi B, GMA, Kaavia and even the lo-cal media have brought to my work,” Kennedy said. “The more kids that understand the importance of saving and investing at a young age, the more financially secure they will be as adults.”

Judge Denies R. Kelly’s 2nd Attempt to Get Released From Prison Because of COVID-19 Risk

Nationwide — For the second time, a judge has ordered that R. Kelly should remain in prison despite his requests to be released on bail due to the coronavirus pandemic.

U.S. District Judge Ann M. Donnelly acknowledged Kelly’s first claims that the conditions at the Metropolitan Correctional Center have worsened since the spread of the coronavirus. However, she noted that, based on provided evidence, the singer is not uniquely at risk to contract the virus.

Kelly then argued in his second attempt that he is not a flight risk as he said he showed up for scheduled court appearances. The judge still denied it as Kelly is facing additional charges for allegedly tampering with witnesses.

“Given the pandemic, where the judicial system’s oversight capabilities are curtailed, these measures simply are not viable — they cannot ensure that a defendant with a history, incentive and opportunity to interfere with potential witnesses will not do so,” Donnelly said.



Meanwhile, authorities said that an inmate on the same floor Kelly is jailed has recently been taken to the hospital due to COVID-19. The judge’s decision still did not change despite that.

Kelly has been in the Metropolitan Correctional Center before he faces trial on obstruction of justice, racketeering and child pornography charges in New York. He is also facing several sex crime charges in Chicago and Minnesota.

Majority of NFL First Round Picks Have Black Agents

Three years ago, The Undeatead featured Adisa Bakari, a former Division I-AA football player and founder of The Sports & Entertainment Group, a Washington, D.C.-based sports agency that represents some of the top athletes in the NFL and professional boxing.

After three seasons and realizing that a playing career wasn't in the cards, Bakari mapped out a successful plan to represent athletes.

For African American sports agents like Bakari, the NFL represents a unique opportunity to represent athletes of color.

The most recent demographics show that 70 percent of the NFL's approximately 1,700 players are black.

Over three days, beginning Thursday, April 23, about 256 young men were selected by NFL teams in the 2020 draft. What's more, the Washington Post reported that for the first time in NFL history, more than half of the players selected in the first round of the draft were represented by Black agents.

It is the first round that guarantees the new college graduates million-dollar contracts and generation-altering wealth.

Seventeen of the 32 selections Thursday night counted African Americans among their representatives. (More than one agent represents some players.) The scattered remote locations did nothing to diminish the significance of the milestone for a group of elite, mostly under-40, African American agents.

They all say they've dealt with what they describe as implicit bias when making their pitches to families of all colors.

"I don't think families entertained

having an African American agent for a long time," agent David Mulugheta, who led the list with four first-rounders, told the Post.

"People look at a young Black kid and think, 'What can he really do for me?' I still get that to this day, to be honest with you, and I've been in the business for a while. I think you have a lot of players now who feel they don't have to go with the status quo."

The newspaper broke down the agents in their selections (agents and the players):

All the contacted agents pointed to the late Eugene Parker as the "godfather" of Black agents who inspired many to pursue careers in the field, the Post noted. Parker, who died in 2016 at age 60, represented Hines Ward, Emmitt Smith, and Walter Jones, among others, and is often described as the first Black "super agent."

"Eugene set the tone for all Black agents," Lynn said.

Mulugheta added that "seeing him told a lot of people that you don't need to be an athlete to stay involved in sports. Growing up, I never saw a Black agent, so that wasn't something I saw as possible, but once I was leaving college, that's when I found out about Eugene Parker."

Check Engine Light On? Could Be A Faulty O2 Sensor

(Car Care Council) - According to the annual CarMD® Vehicle Health Index™ one of the most common check engine light repairs is replacing the oxygen sensor. "Vehicles with faulty oxygen sensors typically seem to drive and handle well, but the malfunction can dramatically decrease fuel efficiency and lead to costlier repairs if ignored," said Rich White, executive director, Car Care Council. "A faulty oxygen sensor means your vehicle is emitting more pollutants and if the check engine light is illuminated, it may not pass vehicle emissions testing in those states requiring it for vehicle registration."

A vehicle's oxygen sensors are mounted in the exhaust system; they monitor the catalytic convertor's operation and the level of oxygen in exhaust gases to maintain efficient engine operation. The best way to prevent an oxygen sensor failure is to follow a regular service schedule, including routine oil changes.

Unlike the past nine years of the annual CarMD report, costly catalytic converter replacement edged out O2 sensor replacement as the most common check engine light repair. Catalytic converters do not typically fail unless maintenance and other repairs are ignored or the vehicle is older. Average vehicle age has increased from 10.6 years to 11.7 years over the past decade, contributing to this outcome.



"It is important that car owners check the reason

for an illuminated check engine light without delay and make necessary maintenance to avoid more costly repairs, like catalytic converter replacement, down the road," said White. "If you find your vehicle needs service, call your trusted local repair shop as automotive repair is considered an essential service."

now died in the United States with confirmed cases nearing one million. Demographic data has showed that across the nation black people are disproportionately contracting and dying from Covid-19. In the state of Ohio and Lucas County respectively, both Governor Mike DeWine and Toledo Mayor Wade Kapszukiewicz have acknowledged this disturbing trend.

Ms. Hicklin said that she personally knows four African-American people in Toledo including two friends that have died after contracting the virus.

"It's unfortunate at this point in time that with so much that has happened our people are not getting it. But because this happened to me, I'm going to keep letting you all know how serious this is because I don't want to bury anybody else," Ms. Hicklin said. "It almost feels like it's becoming a conspiracy that has happened on purpose because a lot of brown and black people have died."

Ms. Hicklin continued, "This isn't anything to play with. Please, please, please wear your masks and get disposable gloves. And disposable means throw them away. Don't cross contaminate. Don't go to Walmart wear the gloves and them turnaround and then use those same gloves to drive your car home."

While in recovery, Ms. Hicklin says God has placed her on assignment. She is currently posting daily inspiration on her public Facebook page, and speaking out about her experience and the gravity of the coronavirus epidemic for individuals and minority communities.

When asked to encapsulate her message to brown and black people in one statement, she said, "Please let your life be worth something to you."

"My son is my pastor and I worship in Detroit at New Bethel Baptist Church (on 2nd Sundays). I do Bible study at the Sparrows Nest on the 3rd Monday's and I fed the homeless on 1st / 4th Sundays," Ms. Hicklin added.
