

# WHEW Inc. hosted a walk to end DV, rape, assault against women

Nine women ignored the chilly weather on Saturday, October 17, to deliver a message; stop domestic violence, sexual assault, rape, and child abuse. WHEW Inc., Women Helping Encourage Women Inc., delivered that message throughout the neighborhood between the shopping plaza on Dorr and Collingwood, where they started their walk, to the Frederick Douglas Community Center, 1001 Indiana Ave.

Once they arrived at the Douglas Frederick Center, walkers, and attendees would be treated to complimentary bagels, and coffee, before continuing their program, which featured various speakers, via live stream, addressing the topics of the program.

Rochelle Morrishaw, founder/ CEO told The Toledo Journal they wanted to bring more awareness to all of the crimes perpetuated against women, and children.

A champion of women's rights, and safety, Ms. Morrishaw has a degree in criminal justice, and was even had the opportunity to join the Secret Service, but

decided to pursue advocating for women instead of going into law enforcement. In addition, she is also a survivor of domestic violence, sexual assault, rape, and child abuse.

seeing After how some law enforcement officers and judges treated victims of these crimes, I knew I had to go into a field that advocates and protects women," she said. "Some police and judges speak to the victims as if they committed the crime; it's sickening."

Besides advocating for women, Ms. Morrishaw has extensive training in areas such as

strangulation, in order to help her identify abuses a victim may have experienced, but yet who

may be too scared to talk about that abuse.

"I've taken two in-depth classes on strangulation, and I continue to learn something I didn't know," she said.

Former first lady Michelle Obama believes America needs a fresh start and urged undecided voters to empathize with Black women.

"I want everyone who is still undecided to think about all those folks like me and my ancestors," Obama stated in a video released

# on Oct. 6 by the Biden-Harris

"The millions of folks who look like me and fought and died and toiled as slaves and soldiers and laborers to help build this country." "Racism, fear, division, these are powerful weapons. And they can destroy this nation if we don't deal with them head-on."

During the 2016 presidential campaign and amid constant attacks by then-Republican nominee Donald Trump against Democrat Hillary Clinton, Obama spoke of raising the bar in the battle of barbs and innuendo.

"When they go low, we go high," she famously stated. In the new video billed as Obama's "closing argument," the popular former first lady pointed out Biden's decades of public service and his perseverance in


the aftermath of the tragic deaths of his wife and young daughter and eldest son.





(TriceEdneyWire.com) - With November 3rd less than a month a way, Black women voters hold a huge stake in this year's election. With the first Black woman vying for the vice-presidency, a recent poll of 506 likely 2020 Black women voters conducted from September 30-October 4, 2020 by Higher Heights and Change Research, showed that 75 percent of Black women are now more motivated than ever to vote. But the remaining 25 percent of Black women polled are feeling hopeless that their ballot won't bring the change they want to see.

In the poll, the top priorities and anxieties about the upcoming election for Black women included: the desire for a stronger response to the coronavirus and the need for racial justice. In addition, the Black women polled noted that when it came to the demographic who could bring about the change the United States needed with voter turnout, an overwhelming 64 percent, of course, chose Black women.

Over the last two presidential elections, Black women have con-

tinued to show up and show out. Whether it was voting for Barack Obama or Hillary Clinton, Black women have been at the forefront of trying to protect the United States from eating itself alive. But over the last 4 years, the Black community has dealt with everything from the coronavirus to the state sanctioned killings of Black people at the hands of law enforcement, as well as voter disenfranchisement.

For example, in Harris County, Texas, home to 2.4 million voters, Gov. Greg Abbott allowed the closing of ballot drop off sites, which has now resulted in several lawsuits. This is one of several examples of how voter suppression is in full force this election. But these tactics, along with long lines, changes to voting and the present pandemic won't keep Black women from the polls. When asked in

# Trump Turns His Back On Struggling Americans, Small Businesses, State And Local Governments

(TriceEdneyWire.com) - "Today's failure to deliver badly needed fiscal assistance to cities of all shapes and sizes is going to amount to increased job losses, decreased public safety and a greatly impaired economic recovery. Cities across the country have been struggling with budget shortfalls for months as a direct result of the pandemic, and hundreds of bipartisan mayors have been echoing the call to congressional and administration leaders for an economic lifeline in the form of immediate flexible fiscal relief. The victims of today's failure will be the American people - residents in cities across the country - led by Republicans, Independents and Democrats who will see critical services further reduced or eliminated entirely." - U.S. Conference of Mayors

On the same day that Federal Reserve Chair Jerome Powell warned that the U.S. economy would face "tragic" consequences without additional federal stimulus, President Trump announced there would be no stimulus until after the election.

"I have instructed my representatives to stop negotiating until after the election when, immediately after I win, we will pass a major Stimulus Bill that focuses on hardworking Americans and Small Business," he tweeted.

In response to his recklessness, the stock market plummeted.


He immediately backtracked, calling for a bill that would land \$1,200 checks emblazoned with his name in voters' mailboxes days before they cast their ballots, still refusing to entertain a comprehensive aid package.

"All the president wants is his name on a check," Speaker of the House Nancy Pelosi said. "We're here to honor our heroes, crush the virus, put money in the pockets of the American people beyond a check with his name on it."

Last week, the House passed an updated version of the HEROES Act that includes support for small businesses; invests in testing, tracing, and treatment; and provides direct payments of \$1,200 per taxpayer and \$500 per dependent. Notably, it includes support for state and local governments – a sticking point for an administration that still thinks it can sabotage Democratic governors and mayors by withholding aid, even as the virus wrecks the economies of Republican-run states and cities as well.

Right now, 26 million Americans are receiving unemployment insurance – payments which were drastically slashed when the federal supplement expired on July 31. Those who lost their jobs early in the pandemic are about to see their benefits expire entirely.

Major companies including Disney, Allstate and two major airlines, have announced plans to fire or furlough



state and local governments have been lost as a result of falling revenues.

The President's assessment of the situation? "Our Economy is doing very well."

From the vantage point of the wealthiest Americans, it may appear so. But, as Chairman Powell observed on Tuesday:

The burdens of the downturn have not been evenly shared. The initial job losses fell most heavily on lower-wage workers in service industries facing the public—job categories in which minorities and women are overrepresented .... Combined with the disproportionate effects of COVID on communities of color, and the overwhelming burden of childcare during quarantine and distance learning, which has fallen mostly on women, the pandemic is further widening divides in wealth and economic mobility.

Early in the pandemic, President Trump bafflingly retweeted meme that compared him to Nero fiddling while Rome burned. In actively sabotaging the nation's economic recovery, he's doing worse than fiddling; he's pouring gasoline on the fire.

the survey, 'what is one word or phrase that best describes your motivation for voting this year?' participants responded with the need for change and racial justice.

As COVID continues to disproportionately affect Black

Black children being safe once they leave their homes on a daily basis. Only 34 percent of respondents said they felt more hopeful of the progress that has been made in light of the recent protests, whereas 38% said they didn't feel any different from before the protests, and 28 percent stated they felt less hopefully. Across the country, we saw millions of people hitting the streets in protest and allies standing in solidarity to the systemic racism that has engulfed this country for centuries. Black women know that the only way to rid the country of its vile history is by voting, and not only on a national level, but also on local levels. Black women know that we possess a political power like no other, and the poll results are reflective on that, particularly when 50 percent of the women polled said they felt motivated by the upcoming election. Across the country, many people have already voted using mail-in ballots. But on November 3rd, others will head to their local polling location and cast their vote. And although

more than 60,000 workers. At least 164,000 businesses have closed since March.

Between 10 million and 14 million renter households are behind on their rent, putting as many as 34 million people at risk of eviction.

And more than 1.2 million jobs in

and Brown communities, this election's turnout is tantamount in putting someone in office who is capable of instituting laws that will protect the Black community's health, as well as providing assistance to those who have been displaced from their homes or have faced unemployment. 48 percent of the respondents stated that the coronavirus was a top issue for them personally. But when it comes to what keeps them up at night, weeks before the election, racism was the most common response.

After a summer of protests and Black deaths at the hands of law enforcement, the poll results show that Black women voters are concerned about being safe in their Black skin, and if they would end up like Breonna Taylor. Others were also concerned about their

# Couple Brought Over 3,000 Black People Together to Build an Affordable Community

Majesty and Elize have founded EVOPIA.org, a free membership platform that uses the power of real estate to protect the economic, health, and political interests of Black people globally. With the support of 3,000 members, they have moved forward to develop an affordable, sustainable, community in Atlanta, GA.

The new development will provide cost-effective, contemporary homes for people who are disproportionately affected by the housing crisis in the metro area. Members of EVOPIA have an opportunity to get involved with this development and other commercial real estate projects. The new homes will serve as a family-friendly community and will offer services like financial literacy and job training to residents. EVOPIA has successfully renovated residential property for this purpose, and are under contract to purchase a 45,000sq ft hotel to provide more shelter during the pandemic.

The non-profit focuses on pooling the resources within the black community for the benefit of the entire African diaspora. EVOPIA is establishing 25 chapters across the country to rehabilitate black neighborhoods. Each chapter will be responsible

for opening a local food bank.

# **CDC Greenlights Evictions Despite Continued Pandemic**

Landlords can resume eviction proceedings after the Centers for Disease Control and Prevention issued clarifications to a previous executive order from President Donald Trump.

The CDC's memo released this week noted that its order "isn't

intended to prevent landlords from starting eviction proceedings, provided that the actual eviction of a covered person for nonpayment of rent does NOT take place during the period of the Order."

Further, the memo states that "landlords are not required to make their tenants aware of" Trump's eviction moratorium and the CDC's declaration form that renters must fill out to qualify.

Following the coronavirus pandemic outbreak, Trump issued an executive order that forced the CDC to temporarily halt evictions through the end of the year.

Diane Yentel, the nonprofit National Low-Income Housing Coalition president, suggested that Trump's order should have been accompanied with legislation and substantial emergency assistance.

Yentel declared that monetary aid was necessary because of a "wave of homelessness" facing the country.

Many experts said the government should mimic Washington, DC Mayor Muriel Bowser and the DC City Council.

In September, the DC City Council voted unanimously an extension to Bowser's state of emergency order, which prohibits evictions and ties them to the health emergency.

The Council's action allows Bowser to extend the city's

# What's Behind President Trump's COVID-19 Treatments? What Does it Mean for Us?

(TriceEdneyWire.com) - No matter where you fall on the political spectrum, the entire nation is fixated on, not only the fact that President Donald Trump was infected with COVID-19, but what we all want to know is, what's the deal with those medicines his doctors are giving him? for coronavirus, President Trump has received a number of different drugs - a steroid, an antiviral medication and an experimental drug cocktail. Despite his implications that he is alright and his overture to the public to not fear the coronavirus, it is critical for us all to remember that this virus is not going away any time soon; that his doctors have said he's "not out of the woods yet"; and experimental drugs aren't readily available to everyone.

Projections from the CDC say that deaths from the virus in the United States will top 400,000 by the end of the year. That means that this pandemic has the potential for us to see more than 36,000 cases and 2,700 deaths per day by Christmas. However, the fact that a 74-year old, obese man walked out of the hospital in 2-3 days after contracting COVID-19 should make us want to know more about what doctors gave him.

So, the absolute best thing we can do to protect the health of ourselves and our families is to know as much as possible about the full range of treatments and/ or vaccines that are, or will be, available. But we must continue practicing the CDC guidelines of mask-wearing, social distancing and hand-washing.

First, it is important to understand that there are two phases of a COVID-19 infection. The first phase is the virus infecting the human body, and then the second phase is the one that is most deadly - when the immune system runs at full speed attempting to conquer the viral invaders. The problem this causes is tremendous damage to all of the internal organs, including the lungs, which can eventually lead to death.

President Trump is on a combination of three really powerful drugs. The first is Regeneron monoclonal antibody cocktail, an artificial version of an antibody that is hoped to supply antibodies to help the immune system fight the virus. It is currently in clinical trials, so it does not have Food and Drug Administration (FDA) approval. The second one is Remdesivir, which is also an antiviral drug, which blocks the ability for the virus to duplicate

the latest one added to his treatment: Dexamethasone.

Though the Regeneron monoclonal antibody cocktail doesn't have FDA approval, there is an FDA approval loophole. You can be granted access to experimental treatments for "compassionate use." That's when everything has failed for a patient, and their only hope to try the unapproved drug; otherwise, they might die. The antibodies Regeneron makes are similar to those made by the people who have caught the

like some of the stuff in your body that it needs to reproduce and survive. Unlike Regeneron, Remdesivir has received approval by the FDA under something known as an "emergency use declaration" for COVID-19 patients. Clinical trials showed effectiveness under some circumstances.

Dexamethasone suppresses the immune system if a patient receives this steroid too soon. It could actually prevent the immune system from fighting the virus in the first place. This is a steroid,

virus and survived it.

Regeneron interrupts the virus and stops it from replicating itself thousands of times. What we know so far is that in the clinical trials going on right now, taking Regeneron cuts the time you have symptoms. Regeneron is rarely used to treat patients who have been just diagnosed, like President Trump. It is generally only approved for patients who are hospitalized. But in the case of a sitting president, doctors might have to judge the risks and ben-

efits differently. You might remember that President Trump has a close relationship with billionaire, Leonard Schleifer. Schleifer is the CEO/Founder of Regeneron Pharmaceuticals. He was the guy who was front and center, in March, along with a group of other pharmaceutical executives at the White House when President Trump announced that biotech would solve the pandemic with drugs or vaccines. None of this is a coincidence. Keep your eye on this one. The next drug in the trio is Remdesivir. It is believed to be most effective in the very early stages of the infection. Even Dr Anthony Fauci said: "The data shows Remdesivir has a clear-cut, significant, positive effect in diminishing the time to recovery". It is hoped to supply antibodies to help the immune system fight the virus. Remdesivir is the antiviral drug that was developed in West Africa, to treat Ebola. The way it works is that it confuses the virus because it looks and it works by calming the immune system. But it needs to be used at the right time. This is the most controversial of all the drugs President Trump is being given by his doctors. If a patient is given this too early in their diagnosis, Dexamethasone could actually make things worse by weakening the body's immune system.

Dexamethasone is not a new drug. It has been used in patients with very severe forms of pneumonia, while it is not as effective in less serious pneumonia. Researchers and scientists feel it should only be used in hospitalized patients who are on ventilators or who require supplemental oxygen. The NIH specifically "recommends against using Dexamethasone for the treatment of COVID-19 in patients who do not require supplemental oxygen."

The president is also taking zinc, vitamin D, famotidine, melatonin and aspirin. We don't know whether they have anything to do with the treating his COVID-19 infection. This information is intended not to make sure you get the medications President Trump had, but to know what he had, so that you make informed decisions about your health. Still, don't let your guard down, stay informed and follow the CDC safety precautions and guidelines. History calls Ida B. Wells a suffragist, antilynching activist, journalist, fighter for democracy. She was all these things and more. Born into slavery in 1862 in Holly Springs, Mississippi she defied the laws of white supremacy, challenging the railroads in the courts in 1884 because she wanted her seat in the "ladies" car of the train, not the "Jim Crow" car. The coowner a n d editor of the Free Speech a n d Headlight (later the Memphis Free Press), one of the country's early Black

newspapers, Wells was a fiery journalist.

When her friends – Thomas Moss, Calvin McDowell, and Henry Stewart – the owners of the People's Grocery in Memphis were lynched she decried the

lynchings calling them "cold blooded murders." Her offices were destroyed

> but her life's work was still in its early years. Wells traveled the south investigating and reporting on lynchings. In 1909, in an address the National Negro to Conference, the forerunner to the NAACP (an organization she helped to found), Wells

made clear her position: "Agitation, t h o u g h helpful, will not alone

stop the crime. Year after year statistics are published, meetings are

held, resolutions are adopted and yet lynchings go on...The only certain remedy is an appeal to law. Lawbreakers must be made to know that human life is sacred and that every citizen of this country is first a citizen of the United States and secondly a citizen

of the state in which he belongs."

The activism, research, and dedication of B. Wells lda is continued by yet another generation. Today our cell phones record police violence and brutality. Ida B. Like Wells activists, journalists, lawmakers, and attorneys are dedicated

to telling the truth of violence that terrorizes Black people and communities. Her words echo into history with the George Floyd Justice in Policing Act of 2020 bill seeking a national remedy to locally occurring discriminatory policing and violence

And monuments and memorials rise in her honor. In Chicago, \$300,000 was raised for a monumental sculpture in Bronzeville, the Chicago neighborhood where she lived, worked and raised her family. She is honored with the Ida B. Wells Memorial Grove at The National Memorial for Peace and



# Black Scholars Form Group to Educate and Dismiss Election Myths on Social Media

A group of Black scholars and activists say they refuse to allow misinformation, alternative facts, and other means to discourage African Americans during the 2020 presidential election.

The National Black Cultural Information Trust, a Pan-African initiative led by Washington, D.C.based cultural communications specialist Jessica Ann Mitchell Aiwuyor, seeks to counter fake social media accounts that often discourage Black voters from participating in elections.

The initiative wants to prevent misinformation from turning Black voters against other communities of color.

"The disinformation used to target Black communities is

cultural," Aiwuyor determined. "It's cultural disinformation, which uses cultural issues to infuse false information and cause confusion."

Aiwuyor holds a bachelor's degree in African World Studies, a Master of Arts in Pan African Studies, and a Master of Science,

She noted that fake or covert social media accounts that purport to be behind the American Descendants of Slavery – or ADOS – movement had prodded voters of color to skip the 2020 charges in the death of Floyd in May in Minneapolis.

The scholars and activists have pledged to monitor social media posts and flag those spreading misleading and fake stories.

Aiwuyor added that the group would use website tools that show if accounts have "troll-like behavior."

She remarked that The National Black Cultural Information Trust would actively work to dispel myths and misinformation about voting and slavery.

According to NBC News, the organization's website will direct users to discussions and stories around Black voting and U.S. reparation supporters who reject xenophobic rhetoric and push coalition-building with Black immigrants and Latinos.

The scholars argue that diaspora wars can be loosely described as cross-cultural arguments among different ethnicities of African people who express discontent for various reasons.

It's normal to have a certain level of cross-cultural conflict or discussions, they argue.

However, these conversations take a counterproductive turn when they are internalized and promote anti-Black/white supremacist narratives about each other that hyper-focus on divisions instead of how individuals can best unify for collective freedom, Aiwuyor noted.

She emphasized that "it's time to move from war to understanding" and the importance of the 2020

The misinformation hasn't dissuaded a long line of voters of color in various states across the country seeking to cast their ballots during early voting.

Aiwuyor pointed out one example of the misinformation: how social media used the ADOS hashtag to claim that immigrants, not police officers, were to blame for George Floyd's death. Four police officers face murder, manslaughter, and aiding and abetting vote.

"Black voters continue to face enormous hurdles in the U.S. electoral process. Voter disenfranchisement and suppression are at an all-time high, and this includes poll taxes, polling station closures in Black neighborhoods, voters abruptly removed from the rolls, gerrymandering, strict voter-id and registration laws, and much more," Aiwuyor stated.

"It is imperative that Black communities and our votes are protected and that we are informed of the various sophisticated techniques used to suppress, deter, and or stop Black communities from voting."

# Pastor Indicted After Stealing From Church Member

Pastor Frederick Smith has been indicted on felony theft and identity theft charges after reportedly using the personal information of an elderly church member to make purchases worth thousands of dollars using the credit cards he opened under her name.

Smith, as pastor of New Life Holiness Church in Memphis, has been indicted by a grand jury on two counts of theft of property over \$10,000 and one count of identity theft. He was released on a \$15,000 bond.

It apparently began in May 2015 when Smith went to the church member's home to ask her to join the church's Mother Board. He was able to get her social security number, driver's license, and utility bill, telling her those were requirements to become a member of the board.

The victim said she then began receiving credit card statements in her name with purchases from \$10,000

to \$60,000 even though she had not never did. Meanwil made any purchases..

never did. Meanwhile, Smith's wife, Jerri, who came to the victim's home to beg her

When she confronted Smith about it, he admitted to using her information to apply for the credit cards. He allegedly promised to pay the bills but not to sue Smith, was initially charged in the case as well. The charge against her was not pursued due to insufficient evidence.

# Cheating FL wife murdered by pastor husband



Svlvester Ofori, a Ghanaian pastor from Orlando, Florida, shot and killed his wife, Barbara Tommey, after reportedly discovering that she was having an affair with another man who is a member and choir director at his church. She was also reportedly pregnant with his child. According to YEN, some reports are circulating the idea that Ofori found out about the affair when his wife mistakenly sent him nude photos and videos of herself that were intended to her lover. The reports also say that he eventually found out that his wife was even having sex with the choir director in their own home. He even saw a video of them taken in the jacuzzi. Ofori went to his wife's workplace at the Navy Federal Credit Union in Orlando on September 8 and shot his wife to death. The incident was recorded by a surveillance camera nearby.

Police have confirmed that Ofori has since been arrested.



# **Health Department Issues Halloween Recommendations**

The Health Department is strongly recommending all communities hold trick-or-treating activities on October 31st from 6pm to 8pm. This is to lessen the chances of potential exposure, while trying to keep everyone in Lucas County as safe as possible.

### **TRICK-OR-TREATING**

1. Perform health screen prior to leaving home-do not participate if feeling sick

**2.** If living with people who may be a greater risk from COVID-19, please reconsider participating

3. If child is at greater risk of complications from COVID-19, contact your doctor before participating

4. Masks should be worn at all times 5. Stay with family unit and in your own neighborhood if possible

6. Stay six feet away from other families

7. Limit one family at a time when approaching participating houses

8. Use hand sanitizer frequently during collection

9. Collection bag should have a wide mouth to allow for dropping treats inside

10. Do not eat any candy while participating

11. If possible, wipe off candy wrappers with sanitizing wipes (allow to dry) when arriving home and prior to eating candy

12. Wash before hands eating any candy

moratorium on evictions as long as she opts for one.

The District's law also bans new eviction filings, a move that will last for an additional two months following the end of the pandemic.

Further, notices to vacate are legally unenforceable during the eviction ban.

"When ... my email box is flooded with resident outrage, we want to act quickly, and I agree," D.C. At-large Councilmember Elissa Silverman told reporters. "But we also need to act thoroughly. The entire eviction process needs to be, I think, examined, and all of these recommendations made in the story deserve our consideration." A study conducted by Harvard University's Department of Housing Studies revealed that half of Americans who rent are either severely rent-burdened or moderately rent-burdened.



"It's a good time for the United States to really re-look at our housing policies," Diana Yentel, the nonprofit National Low-Income Housing Coalition president, told Yahoo! News. "And see what changes need to be made post-pandemic or even during the pandemic to help those who were already struggling."

For African Americans and Hispanics, researchers at Harvard determined a triple pandemic for those communities.

Black and Hispanic households were "much more likely to contract COVID-19, suffer lost income, and face housing insecurity as a result of the pandemic," the researchers concluded.

"It's a good time for the United States to really re-look at our housing policies," Yentel told Yahoo! News. "And see what changes need to be made post-pandemic income is less than 2019, and they have to prove that



**Dorothy Lavinia Brown:** Dorothy Lavinia Brown was a prominent black teacher, surgeon and legislator. She was the first African American elected to the Tennessee General Assembly, where she helped pass the Negro History Act, which required Tennessee public schools to teach special lessons honoring the accomplishments of African American during Black History Week.

**Bobby Womack:** Bobby Womack was an African American singer, songwriter and record producer whose career spanned more than six decades and multiple genres of R&B, soul, gospel, doo-wop, rock and roll, and country. Some of his biggest hits include "Lookin' For a Love," "That's the Way I Feel About Cha," and "Woman's Gotta Have It."

Interracial marriages were outlawed in 1664, and the decision wasn't overturned until 1967, when a Black woman named **Mildred Jeter** married Richard Loving, a white man in the District of Columbia. The couple was arrested upon their return to Virginia, but the Supreme Court ruled in their favor in the famous Loving vs. Virginia trial.

On **Maya Angelou's** birthday, April 4, 1968, Martin Luther King, Jr. was assassinated. Angelou stopped celebrating her birthday for years afterward, and sent flowers, to his widow, Coretta Scott King, for more than 30 years until Coretta's death in 2006.

**October 19 to 27, 1960**: Eight months after lunch counter sit-ins begin in Greensboro, N.C. Dr. King and 51 other demonstrators are arrested during a sit-in while waiting to be served at an Atlanta restaurant.

As other jailed demonstrators are released, Dr. King is held on a charge of violating a probated sentence in a traffic arrest case. He is transferred to the DeKalb Conty Jail in Decatur, Ga., and is then transferrred to the Reidsville State Prison on a \$2,000 bond. He is released after presidential candidate John F. Kennedy and his brother and campaign manager, Robert, intervene.

**October 24, 2005:** United Nations Day Rosa Parks passes away in Detroit, Mich.

(Black News) - Growing up, McGowan has been surrounded by a family who is fond of motorcycles. It has made an influence on her since then that she decided to apply for a job at a Harley-Davidson store two years ago.

Eventually, she was able to buy her own motorcycle that she has always wanted to become a better rider. Also with the eagerness to know how things work and fix them, she decided to be trained as a technician. Just last month, she graduated from the Motorcycle Mechanics Institute with a specialty in Harley-Davidson, making her the first Black woman to do so.

"I'm the first African-American female

"I was told by a lot of people to just be a nurse instead," McGowan continued. "Don't listen to anybody that shuts you down from your dream. Do not, because they don't know you. They don't know where you came from."
